- 1. The amalgamated EC letter should be read along with the original EC issued vide letter dtd 23.01.16, 24.02.2015 and its amendments 20.06.17. All the conditions mentioned in the prior EC shall remain the same. PP should submit the six-monthly Compliance report accordingly on regular basis.
- 2. After amalgamation, all assets and liabilities of M/s Rathi Iron & Steel Industries Ltd. including the manufacturing site of the Industrial area Pithampur, shall be fully owned and managed by M/s Jaideep Ispat & Alloys Pvt. Ltd.
- 3. No change in mining technology and scope of working shall be made without prior approval of the SEIAA.
