 - (1) The Prior Environmental Clearance under EIA Notification, 2006 & its amendments has been issued (vide letter No. 75/SEIAA/ 2017 dated 19.06.17) for the proposed Clinker grinding unit (2 x2 MTPA) of Wonder Cement Limited at Village- Kherwas, Teshil-Badnawar, District. Dhar, (M.P.).
 - (2) The Proponent has applied to amend specific condition number A-3 issued earlier (Vide letter no. No.75/SEIAA/2017 dated 19.6.2017) and requested to allow drawls of water from the water body. Regarding this PP has submitted Detailed Hydro geological study report by assessing the water availability in pond (abandoned quarry) and in and around plant premises.
 - (3) The letter submitted by PP with supporting documents (hydro-geological study report) was examined and considering the direction of Ministry of Environment, Forest and Climate Change, Govt. of India to put emphasis on all industrial units to reduce groundwater withdrawal by using surface water resources is as far as possible. The case was discussed in 625th SEIAA meeting dtd 10.07.2020 and after detail discussion and deliberation, it is decided to accept the request of PP and accordingly specific condition No. A-3 mentioned as "PP should develop and conserve the existing water body within the plant area with proper fencing, landscaping with plantation.

Fountains shall be installed within the water body for aeration. No drawal of water shall be permitted from this water body for domestic and industrial purpose" in EC letter No. 75/SEIAA/ 2017 dated 19.06.17 is hereby amended as below:

"PP should develop and conserve the existing water body within the plant area with proper fencing, landscaping, plantation and installation of fountains within the water body for aeration. Drawl of water is permitted from this water body situated in plant area for domestic and industrial purpose to utilize surface water resources as far as possible and reduce ground water withdrawal."

The amendment should be read along with the original EC issued to PP and all the conditions mentioned in the prior EC vide letter No. 75/SEIAA/2017 dated 19.06.17 shall remain the same.
