The case was recommended in 412th SEAC meeting dated 09.12.2019 and it was recorded that

"...... The case was presented by the PP and their consultant wherein as per Google image based on revised coordinates provided by PP, committee observed that the most parts of the lease is excavated / mined out. PP submitted that they have mined out the area in the year 2012 and since then no mining is carried out by him. Committee backtrack the previous Google images wherein it was observed that in the year 2013 most parts of the lease was almost flat and by 2018 > 50% of the lease area seems to be excavated. Committee after deliberations recommends that it's a case of violation and EC at this stage cannot be considered for this project.."

As per above recommendation of SEAC, it is observed that it is a case of violation hence it is decided that this case cannot be considered as per EIA Notification. Copy to PP and all concerned.
