**Sub: Case No 6928/2020-** Prior Environmental Clearance for Stone Quarry (opencast semi mechanized method) in an area of 4.00 ha. for production capacity of 1,800 cum per annum at Khasra No. 01 at Village - Semrakhedi, Tehsil - Deori, Dist. Sagar (MP) by Shri Amit Kumar Jain, H.No. 181, Mahakali Ward, Deori, Dist. Sagar, (MP)

The case was discussed in 683<sup>rd</sup> SEIAA meeting dtd 27.08.2021 and it was recorded that.....

" .This case was EC granted in 658<sup>th</sup> SEIAA meeting dated 09.02.2021 and it was recorded that...

*Hence, Prior Environmental Clearance is granted for Stone Quarry (opencast semi mechanized method) in an area of 4.00 ha. for production capacity of 1,800 cum per annum at Khasra No. 01 at Village - Semrakhedi, Tehsil - Deori, Dist. Sagar (MP) for the lease period to Shri Amit Kumar Jain, H.No. 181, Mahakali Ward, Deori, Dist. Sagar, MP.*


After detail discussion, it was observed that the Assistant Mining Officer, Sagar vide letter No. 03 dated 02.01.2021 informed that there are 02 other mines area of 4.70 ha. falling under 500 m. radius of the existing mine, hence forming a cluster of 8.70 ha. As per the MoEF&CC, OM dated 12.12.2018 the case is falling under B1 - category. Therefore the EC granted in 658th SEIAA meeting dated 09.02.2021 shall not be issued, it will be kept in hold. It is decided that, PP may call for clarification as per certification given by Assistant Mining Officer, Sagar."

In above context, PP has submitted a copy of letter of the Collector Office (Mining Division), District Sagar dated 26.08.21 mentioning that there are 02 other operating & sanctioned mines located within the 500m periphery of the proposed mine.

On the basis of the above information presented by PP, it is clear that total area of the cluster becomes more than 5.0 ha and this case shall be considered under Category - B1 as per provision of EIA Notification, 2006 and its subsequent amendments.

It is decided that, the case is hereby closed and PP may apply afresh online application for ToR on Parivesh Portal. Copy to all concerned .

As per above decision you are informed that the case is hereby **closed**. You may apply afresh online application for ToR on Parivesh Portal.


