"...As per Google image based on coordinates provided by PP, it was observed by committee that a wind mill located at a distance of 100 m northern side. Committee observed that SEIAA in their 263th meeting dated 28.11.2015 has decided to leave minimum 300 m distance from the periphery of Wind Turbine Generator Foundation with reference to letter no. 1097 dated 20.11.2015 issued by Commissioner, New & Renewable Energy. Committee observed that if 300 meters area is left as non mining area, no area will be available to carryout mining. Thus considering above facts committee after deliberation recommends that this case cannot be considered for grant of EC and case file may be sent to SEIAA for onward necessary action..."
