> The case was scheduled for the presentation wherein it was observed by committee that PP vide letter dated 01/06/2020 has submitted a request for withdrawal of their application. Committee after deliberations decided that on the request of PP case may be considered for withdrawal and same may be sent to SEIAA for onward necessary action.

This case was placed before SEAC for discussion as PP vide letter dated 01.06.2020 has submitted that they do not want to peruse with their case and would like to withdraw and have submitted a request in writing for its withdrawal. As per above recommendation of SEAC, it was decided to close the case as withdrawn by PP. Copy to PP and all concerned.."
