The PP has submitted application vide No. Nil dtd. 12.01.2016 received in SEIAA office on 14.01.2016 requested to make correction in the production capacity as 1,70,685 cum/year in place of 90,000 cum/year as mentioned in the EC letter issued by SEIAA vide No. 6091 dtd. 07.10.2015. The facts regarding production capacity are given hereunder :-

- 1. In Form-1 production capacity is mention as 1,70,685 cum/year and the application was registered as case No. 2799/2015 which was forwarded to SEAC vide No. 491 dtd. 24.04.2015.
- The production capacity in the revised approved mining plan dtd. 07.04.2015 is 1,70,685 cum/year. This document was the part of application.
- 3. The SEAC in its 194th meeting dtd. 31.05.2015 has recommended for production capacity 1,70,685 cum/year.
- 4. The SEIAA in its 236th meeting dtd. 11.09.2015 has granted the production capacity as 1,70,685 cum/year.

Therefore, the production capacity of 90000 cum/year as mentioned in the EC letter vide No. 6091 dtd. 07.10.2015 is hereby corrected as 1,70,685 cum/year and now may be read as :-

"Hence, Prior Environmental Clearance is granted for Sand Quarry (opencast manual method) in an area of 6.00 ha, for production capacity of 1,70,685 cum/year at Khasra No. 01 at Village-Barkola, Tehsil-Ajaygarh, District-Panna (M.P) for the lease period to Shri Ravindra Prasad Shukla, Prop., M/s Maa Padmawati Shakti Enterprises, Ranibag, Panna (MP)-488220. "

The other terms and condition mentioned in EC letter No. 6091/SEIAA/2015 dtd. 07.10.2015 shall remain the same.
