This case was discussed in the 297th SEIAA meeting dtd. 19.02.2016. EC conditions imposed have been reviewed and examined again and additional conditions for grant of EC are hereby imposed as under :-

- Before commencing the mining activity, site demarcation should be done leaving 100 m. from east side, leave aside the village as a "no mining zone". The demarcation should be done by the Revenue Officials in the presence Mining Officer, Tikamgarh.
- No excavated material should be dumped on eastern side.

In light of above, two additional conditions are hereby imposed as corrigendum in the Original EC letter issued Vide L.no. 948 dtd. 25.04.2016. All the specific conditions mentioned in the Prior EC dtd (25.04.2016) shall remain the same, along with above imposed conditions at Point No.20 & 21.
