The case was discussed in 663rd SEIAA meeting dtd, 26.02,2021 and it was recorded that:-

The case was discussed in 641st SEIAA meeting dated 03.10.2020 and EC was issued vide letter no. 4313-14/SEIAA/20 dated 27.10.2020.

Thereafter the case was discussed in 657th SEIAA meeting dated 30.01.2021 and it was recorded that....

" PP has requested vide L.No. nil dated 23.12.2020 for amendment of production capacity 30000 TPA in place of the production capacity 30000 cum/year as mentioned in EC issued vide letter no. 4313 dated 27.10.2020.

It seems that in the EC was issued on the basis of the recommendation made in minutes of 458th SEAC Meeting dtd 22.09.2020. It is decided that case sent to SEAC with technical file and with the request letter of PP for re-appraisal. Copy to PP."

After that the case discussed in 482nd SEAC dated 17.02.2021 and it was recorded that ...

"....... The case was discussed in 656th SEIAA meeting dtd. 30/01/2021 and it was recorded that...... "PP has requested vide L.No. nil dated 23/12/2020 for amendment of production capacity 30,000 TPA in place of the production capacity 30,000 cum/year as mentioned in EC issued vide letter no. 4313 dated 27/10/2020. It seems that the EC was issued on the basis of the recommendation made in minutes of 458th SEAC meeting dated 22/09/2020. It is decided that case sent to SEAC with technical fill and with the request letter of PP for re-appraisal. The case was placed before the committee wherein it was informed to the committee that due to typographical error, the quantity was recommended as 30,000 cum/year while PP has applied for 30,000 TPA. PP has requested for necessary change in the issued EC letter. Committee observed that being typographical error, it is recommended to issue corrigendum and recommended quantity shall for Laterite mining in an area of 4.253 ha., for 30,000 TPA as per approved mine plan.

The committee discussed the matter in detail and decided to accept the SEAC recommendation that in this case the production capacity may be read as 30,000 TPA in place of 30,000 cum/ annum. Copy to PP and all concerned.

The corrigendum should be read along with the original EC issued vide letter dtd. 27.10.2020. All the conditions mentioned in the prior EC letter (dtd. 27.10.2020) shall remain the same.
