The Prior Environmental Clearance under EIA Notification, 2006 has been issued for the proposed **Synthetic Organic Chemical manufacturing Unit** of M/s Meghnagar Pharmachem Pvt. Ltd., Plot No. 98-A, AKVN, Meghnagar, Village Meghnagar, District Jhabua (M.P.).The Proponent (vide letter 09.09.16 received in SEIAA office on 09.09.16) requested for correction in point. no. (vii) & (viii) of the EC issued earlier (vide no. 9709 dtd 23.12.15.). The case was discussed in 370<sup>th</sup> SEIAA meeting dtd 26.09.2016 and 378<sup>th</sup> SEIAA meeting dtd 20.10.2016 and it is decided to issue a corrigendum as follows:-

Further PP has also has requested for amendment in conditions no. (7), (15) and (16) under specific condition imposed by SEIAA the amended are as follows :-

Regarding Point No. 7- The condition of dismantling of their existing plant mentioned in the EC issued on dated 23.12.15 will remain same. However, some of plant and machineries of the existing project can be utilized for the proposed products subject to verification and permission of Regional Officer, M.P. Pollution Control Board.

Regarding Point No. 15 & 16 - PP has submitted that 2.5 mm thickness of HDPE geo membrane liners are not available in the market and therefore the specification may be reduced to 1-1.5 mm. In the meeting the availability of 2.5 mm liners were checked from the website of the manufacturers and it was found that 2.5 mm liners are available in the market. Therefore it has been decided not to reduce the specifications and stick to the already approved specification as indicated in the EC letter.

The corrigendum should be read along with the original EC issued vide letter dtd 23.12.2015.All the conditions mentioned in the prior EC (dtd 23.12.2015) shall remain the same.
