The Prior Environmental Clearance under EIA Notification, 2006 has been issued for the API Manufacturing Unit Pithampur Industrial Area, Sector - III, Taluka - Dhar, Dist. Dhar, (M.P.)

The Proponent (vide letter dtd 19.03.19 received in SEIAA office on 20.03.2019) requested for correction in the prior EC issued earlier. The case was discussed in 389th SEAC meeting dtd 09.08.2019 and 568th SEIAA meeting dtd. 28.08.19 and it is decided that to issue a corrigendum as follows: "the specific condition Point No. 7 regarding continuous stacks emission monitoring system imposed in EC is hereby excluded in the light of MoEF&CC notification GSR 96 (E) dated 29.01.2018 and diesel generator capacity figure shall be read as 625 KVA instead of 163 KVA as it was recorded due to typographical mistake. The other recommendation made in EC remains unchanged."

The corrigendum should be read along with the original EC issued vide letter dtd 13.11.18. All the conditions mentioned in the prior EC (dtd 13.11.18) shall remain the same.
