The Prior Environmental Clearance under EIA Notification, 2006 has been issued for the Area Based Development Project" for Bhopal Smart City Kotra Sultanabad, Bhopal City (North & South T.T. Nagar) Tehsil Huzur District Bhopal MP vide letter no. 1304 dtd 23.08.18.

It has been observed by the authority that there is some discrepancy in plantation area of EC letter issued to project dtd. 23.08.18 (specific condition Point No. D- 70) is as follows:-

"As proposed, 8.5 % area has earmarked of the total area of the ABD for the green belt development / plantation and the proposed species should also be planted in consultation with the forest department."

In the EC letter instead of 23.53 ha (17%) it has been written 8.5% area. It should be read as follows:-

"As proposed, 23.53 ha (17) % area has earmarked of the total area of the ABD for the green belt development / plantation and the proposed species should also be planted in consultation with the forest department."
