Sub:-Case No. – 7512/2020: Prior Environmental Clearance for Stone Quarry (Opencast Semi Mechanized Method) in an area of 4.00 ha. for production capacity of 1,00,000 cum per annum at Khasra No. 833 at Village-Dang Sarkar, Tehsil-Gohad, District-Bhind (MP) by M/s Maa Durga Stone Crusher, Shri Amit Dantare S/o Shri Jayprakash Dantare, R/o Konhar, Tehsil - Mehgaon, Dist. Bhind (MP)–47700 - Regarding correction in the production capacity.

PP has requested to make changes in production capacity of 100000 cum per annum instead of 300000 cum per annum. Due to typographical mistake, it was recorded as below in minutes of 635 SEIAA meeting dated 01.09.20 and accordingly EC transfer letter issued vide No.3724/SEIAA/20 dated 16.10.20. The case was discussed in 650th SEIAA meeting dtd. 28.12.2020 and it is decided to issue a corrigendum as follows:

".......In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued DEIAA Bhind on 20.3.2019 in the name of "Shri Aarti Shrivastava R/o Jawahar Road Mehgaon District-Bhind MP.." is hereby transferred to M/s Maa Durga Stone Crusher, Shri Amit Dantare, S/o Shri Jayprakash Dantare, R/o, Konhar, Tehsil - Mehgaon, Dist. Bhind, MP - 477001, for Stone Quarry in an area of 4.00 ha. for production capacity of 3,00,000 cum per annum at Khasra No. 833 at Village-Dang Sarkar, Tehsil- Gohadj, District-Bhind (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. All concerned be informed accordingly.

After discussion, it was decided to issue corrigendum and it will now be read as below-----
