Earlier PP was also absent in the 383rd SEAC meeting dated 10/07/2019 & SEAC 372nd meeting dated 22-05-19. Committee decided that since sufficient opportunities have been given to the PP for appraisal and consideration of the project wherein PP remain absent, the case shall be returned to SEIAA for delisting assuming that PP is not interested to continue with the project.

As per above recommendation of SEAC, it has been decided to delist the case on the condition that if PP intends to present the case in SEIAA, it will then be relisted for appraisal. Copy to PP and all concerned."
