Earlier PP was also absent in 472nd SEAC meeting dated 6/1/2021 & 470th SEAC meeting dated 18/12/2020. Committee decided that since sufficient opportunities has been given to the PP for appraisal of their case but PP remains absent thus committee decided that case shall be returned to SEIAA for delisting assuming that PP is not interested to continue with the project.."
