The case was discussed in 675th SEIAA meeting dtd 08.04.2021 and it has been recorded that

".....The case was scheduled for the presentation but neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Committee decided to call the PP in subsequent meetings. Since the tenure of SEAC will be over on 09th April, 2021 and all such cases which are pending at SEAC will become category-I cases in the absence of SEAC. Thus case file is being sent to SEIAA for onward necessary action please."

As per above observation of SEAC, it has been decided to delist the case on the condition that if PP intends to present the case in SEIAA, it will then be relisted for appraisal. Copy to PP and all concerned"

As per above decision, you are hereby informed that your case is delisted and liable for relisting if you intends to present the case in SEIAA. As in the absence of duly constituted SEIAA & SEAC, a Category 'B' project shall be treated as a Category 'A' project.
