* In context of above, it is decided that PP should submit revised EIA report by incorporating all the issues as raised by SEAC. EIA consultant firm M/s Amaltas Enviro Industrial Consultants LLP, New Delhi is also instructed to not repeat this type of mistake in future.

Further it was observed by the authority that this type of issue could have been resolved by SEAC only itself by raising ADS to avoid delay in dispose of the case.
