After detail discussion it is observed that there are no any other mines are operated/sanctioned within 500 m. periphery of proposed mine. After that committee has decided to following amendments in EC condition No. 10 as per Prior EC issued by DEIAA Betul vide Letter No. 65/DEIAA/16 dated 05.10.2016 shall be complied by PP:

- PP shall ensure to carry out blasting procedure following using delayed detonators to reduce the vibration impact of L waves. Both 34 mm and 83 mm bore blast should strictly follow these procedures. The maximum quantity of explosive used should not be more than 500 kgs, if the distance is up to 200m.
- 2. Before commencing the mining activity, site demarcation should be carried out leaving 200 m. distance from the dam side as a "no mining zone" in compliance of the distance criteria for permitting stone quarrying by CPCB and directions issued by Hon'ble NGT in OA No. 304/2019. The demarcation should be carried out by the WRD Officials in the presence of the Mining Officer, Betul. PP shall also ensure to carry out three row plantation towards the dam side in consultation with the Forest Department.

As per the above decision, you are hereby informed that the amendments in EC (condition No. 10 as per Prior EC issued by DEIAA Betul vide Letter No. 65/DEIAA/16 dated 05.10.2016) as recommended above shall be complied and other condition will remain unchage.
