Sub: Case No. 2548/2015: Prior Environmental Clearance for Sand Quarry (Opencast Manual Method) in an area of 6.00 ha. for production capacity of 10,000 cum/year at Khasra no.520 at Village- Samgeemana, Tehsil- Agar, District - Agar Malwa (MP) by Shri Hafijur Rehman S/o Shri Ajjur Rehman, Village- Chouma, Tehsil - Mobadodiya, Shajapur (M.P.).

The case was discussed in 467th SEIAA meeting dtd. 02.02.2018 and it was recorded in the minutes that.....

"Mining Officer, Agar Malwa has submitted application for transfer of Prior EC in the name of Sarpanch, Gram Panchayat - Samgimana, Tehsil-Agar, District-Agar Malwa from Shri Hafijur Rehman S/o Shri Ajjur Rehman R/o Village Chouma, Tehsil Mo- Badodiya, District Shajapur through vide letter No. 942 dated 23-01-2018. After examination of all documents submitted by the Mining Officer, Agar Malwa, it is observed that the Prior EC was issued vide letter No. 4661-62 dated 12.08.2015 to Shri Hafijur Rehman S/o Shri Ajjur Rehman and the above lease was cancelled by Collector, Agar Malwa vide order No. 605 dated 01-10-2016.

It is clear that the mining lease allotted to Shri Hafijur Rehman S/o Shri Ajjur Rehman is not in existence. Since Prior EC was granted to Shri Hafijur Rehman S/o Shri Ajjur Rehman for lease period hence, Prior EC issued to Shri Hafijur Rehman S/o Shri Ajjur Rehman is hereby cancelled due to non existence of mining lease in their name and Prior EC cannot be transferred to Sarpanch, Gram Panchayat - Samgimana, Tehsil-Agar, District-Agar Malwa. Copy to all concerned."

In view of above decision Prior EC issued (vide letter no.4661/SEIAA/15 dtd 12.08.2015) to Shri Hafijur Rehman S/o Shri Ajjur Rehman is hereby cancelled due to non existence of mining lease in their name and Prior EC cannot be transferred to Sarpanch, Gram Panchayat - Samgimana, Tehsil - Agar, District - Agar Malwa.
