"The prior EC was issued to M/s A.D.Agro Foods Pvt. Ltd, Sub Lessee of M.P. State Mining Corporation Ltd, H.I.G.G.D-5, Dindayal Nagar, Phase-1, Kanth Road, Muradabad (UP)-461661.vide Letter No.5546 dtd.10.03.2017 & Corrigendum issued vide Letter No.5755 dtd.31.03.2017 for an area of 18.107 ha. at Village --Bagwada, Tehsil-Budhni, Distt-Sehore (MP).

As per New Sand Mine Policy 2017, Mineral Resources Department, Govt. of M.P. has allotted/transferred non-operational sand mines to gram panchayat/ local body vide letter No. F-19-26/2017/12/1 dated 11.01.2018 and modification letter No. F-19-26/2017/12/1 dated 9.2.18. PP (Gram Panchayat,, Bagwada,Sehore) has requested Collector,Bagwada to make amendment in the Prior EC letter by changing the name of PP of the mining project in the name of Gram Panchayat, Bagwada,Sehore.The above application has been forwarded by Collector (Mining Division), Sehore to SEIAA for transfer of prior EC in the name of Gram Panchayat, Bagwada,Sehore vide letter no. Q/खनिज/2018 dtd15.03.2018.

PP (Gram Panchayat, Bagwada, Sehore has submitted the following documents in support of his request:

- Application of Sarpanch, Gram Panchayat Bagwada, Sehore for transfer of Prior EC in favour of the Gram Panchayat Bagwada, Sehore.
- No objection letter of previous Project Proponent (to whom prior EC was granted) for transfer of prior EC in the name of Gram Panchayat Bagwada, Sehore.
- Notarised affidavit of Sarpanch/Secretary, Gram Panchayat Bagwada, Sehore mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.
- 4. Lease transfer order issued by Office of Collector (Mining Division) to Gram Panchayat, Bagwada, District- ,Sehore vide letter No. 198/खनिज/रेत नीति 2017 / 2018 dated 18.01.2018.
- Copy of Prior EC issued by MPSEIAA vide letter no. No. 5546 dtd.10.03.2017 & Corrigendum issued vide Letter No.5755 dtd.31.03.2017.
- 6. NOC of State Mining Corporation for transfer of EC in the name of Gram Panchayat, Bagwada, Sehore vide letter no रेत /2017—18 /1069 dated 13.2.2018.

As per the notification issued by MoEF&CC on 14.09.2006, the policy on transferability of EC is as follows:-

11. Transferability of Environmental Clearance (EC):

A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases

After detailed discussions on the MoEF&CC Notification regarding transferability and perusal of the above information, it has been decided to transfer the Prior EC issued on 10.03.2017 & Corrigendum issued vide Letter No.5755 dtd.31.03.2017in favour of Sarpanch Gram Panchayat, Bagwada, Dist. Sehore in the place M/s A.D.Agro Foods Pvt. Ltd, Sub Lessee of M.P. State Mining Corporation Ltd, H.I.G.G.D-5, Dindayal Nagar, Phase-1, Kanth Road, Muradabad (UP)-461661.for Sand Quarry (Opencast Manual Method) in an area of 18.107 ha for production capacity of 1,80,000 cum/year at Khasra No. 352/340 at Village--Bagwada, Tehsil-Budhni, District-Sehore (MP) on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. Copy to PP and all concerned."
