Case No. 2865/2015 - Prior Environmental Clearance for River Sand - Bajri Dposit (Opencast Manual Method) in an area of 12.546 ha. for production capacity of 12700 m³/year at Khasra no. 87 at Village – Bakwadi, Tehsil – Rajpur, District- Barwani (M.P) by Sarpanch, Gram Panchayat, Bakwadi, Barwani (MP). - Revised letter for transfer of Prior EC.

The case was discussed in 476<sup>th</sup> SEIAA meeting dtd 24.03.2018 and it was recorded that.......

"The Prior EC was transferred to Gram Panchayat, Bakwadi, Barwani from Shri Manish Thakre, Nimmark Colony, Gali No. 3, Sendhwa, Barwani (MP)-451666 in 468<sup>th</sup> SEIAA meeting dtd. 09.02.2018: Due to the typographical mistake in the title and first Para of the minutes, the name of Shri Lokesh Rajpoot S/o Late Shri K.S. Rajpoot, Barapatthar, Near S.P. Bungalow, Seoni (MP)-480882 has been mentioned in the minutes in place of Shri Manish Thakre. In view of above, it is decided to replace the name of Shri Lokesh Rajpoot S/o Late Shri K.S Rajpoot with Shri Manish Thakre in title & first para and accordingly revised letter be issued by cancelling earlier letter no. 1791 dated 28.02.2018. Copy to PP and all conceren"

In view of above the transfer of EC issued to Sarpanch, Bakwadi District Barwani vide L.No. 1791 dtd. 28.02.2018 is hereby cancelled.

The prior EC was issued to Shri Manish Thakre, Nimmark Colony, Gali No. 3, Sendhwa, Barwani (MP)-451666, vide Letter No. 4611 dtd. 10.08.2015 for an area of 12.546 ha. at Village - Bakwadi, Tehsil – Rajpur, District – Badwani (MP).

As per New Sand Mine Policy 2017, Mineral Resources Department, Govt. of M.P. has allotted/transferred non-operational sand mines to gram panchayat/ local body vide letter No. F-19-26/2017/12/1 dated 23.11.2017 and modification letter No. F-19-26/2017/12/1 dated 9.2.18. PP (Gram Panchayat, Bakwadi, Barwani) has requested Collector, Barwani vide letter No. 03 dated 24.01.2018 to make amendment in the Prior EC letter by changing the name of PP of the mining project in the name of Gram Panchayat, Bakwadi, Barwani. The above application has been forwarded by Mining Division of Collector Office, Barwani to SEIAA for transfer of prior EC in the name of Gram Panchayat, Bakwadi, Barwani vide letter no. 65 dtd 24.01.2018.

PP (Gram Panchayat, Bakwadi, Barwani) has submitted the following documents in support of his request:

- Application of Sarpanch, Gram Panchayat Bakwadi, Barwani for transfer of Prior EC in favour of the Gram Panchayat Bakwadi, Barwani.
- No objection letter of previous Project Proponent (to whom prior EC was granted) for transfer of prior EC in the name of Gram Panchayat Bakwadi, Barwani.
- Notarised affidavit of Sarpanch/Secretary, Gram Panchayat Bakwadi, Barwani mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.

As per the notification issued by MoEF&CC on 14.09.2006, the policy on transferability of EC is as follows:-

11. Transferability of Environmental Clearance (EC):

A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases

Hence, the Prior Environmental Clearance issued to Shri Manish Thakre, Nimmark Colony, Gali No. 3, Sendhwa, Barwani (MP)-451666 vide letter no. 3903 dtd. 21.07.2015 for River Sand - Bajri Dposit (Opencast Manual Method) in an area of 12.546 ha. for production capacity of 12700 m³/year at Khasra no. 87 at Village – Bakwadi, Tehsil – Rajpur, District-Barwani (MP) is hereby transferred to Sarpanch, Gram Panchayat, Bakwadi, Tehsil - Rajpur, District – Badwani on the same terms & conditions and validity period under which the prior environmental clearance was initially granted.
