"The prior EC was issued to Shri Rajeev Saxena, OIC, MP State Mining Corporation, Paryavas Bhawan, Block-A, 2nd Floor, Jail Road, Arera Hills, Bhopal (MP)-462011, vide Letter No. 5657 dtd. 23.03.2017 & Letter No 106 dtd.04.04.2017 for an area of 14.430 ha. for production capacity of 75,000 cum/year at Khasra No.-149/1/1, Village-Jalkota, Tehsil-Maheshwar, District Khargone (MP)

As per New Sand Mine Policy 2017, Mineral Resources Department, Govt. of M.P. has allotted/transferred non-operational sand mines to gram panchayat/ local body vide letter No. F-19-26/2017/12/1 dated 23.11.2017 and modification letter No. F-19-26/2017/12/1 dated 9.2.18. PP (Gram Panchayat, Jolkota, Khargone) has requested Collector, Khargone vide letter No. 3147/खनिज/18 dated 16.01.2018 to make amendment in the Prior EC letter by changing the name of PP of the mining project in the name of Gram Panchayat, Jolkota, Khargone. The above application has been forwarded by Mining Division of Collector Office, Khargone. to SEIAA for transfer of prior EC in the name of Gram Panchayat, Jolkota, Khargone vide letter No. 3264/खनिज/18 dated 23.01.2018 & 3859/खनिज/18 dated 27.03.2018. PP (Gram Panchayat, Jolkota, Khargone) has submitted the following documents in support of his request:

- Application of Sarpanch, Gram Panchayat, Jolkota, Khargone for transfer of Prior EC in favour of the Gram Panchayat Jolkota, Khargone
- No objection letter of previous Project Proponent (to whom prior EC was granted) for transfer of prior EC in the name of Gram Panchayat Jolkota, Khargone
- Notarised affidavit of Sarpanch/Secretary, Gram Panchayat Jolkota, Khargone mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.
- 4. Lease transfer order issued by Office of Collector (Mining Division) to Gram Panchayat, Jolkota, Khargone vide letter No. 3147/खनिज /18 dated 16.01.2018
- Copy of Prior EC issued by MPSEIAA vide letter No. 5657 dtd. 23.03.2017 & Letter No. 106 dtd.04.04.2017
- 6. NOC of MP State Mining Corporation for transfer of EC in the name of Gram Panchayat, Jolkota, Khargone vide letter /धामनोद/रेत /2017–18 dated 9.02.2018.

As per the notification issued by MoEF&CC on 14.09.2006, the policy on transferability of EC is as follows:-

11. Transferability of Environmental Clearance (EC):

A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferoe with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on

the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases

After detailed discussions on the MoEF&CC Notification regarding transferability and perusal of the above information, it has been decided to transfer the Prior EC issued on 23.03.2017 & 04.04.2017 in favour of Sarpanch Gram Panchayat, Jolkota, Dist. Khargone in the place Shri Rajeev Saxena, OIC, MP State Mining Corporation, Paryavas Bhawan, Block-A, 2nd Floor, Jail Road, Arera Hills, Bhopal (MP)-46201 for Sand Quarry (opencast manual method) in an area of 14.430 ha. for production capacity of 75,000 cum/year at Khasra No.-149/1/1, Village-Jalkota, Tehsil-Maheshwar, District Khargone (MP) on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. Copy to PP and all concerned."

Hence, the Prior Environmental Clearance issued Shri Rajeev Saxena, OIC, MP State Mining Corporation, Paryavas Bhawan, Block-A, 2nd Floor, Jail Road, Arera Hills, Bhopal (MP)-46201 vide letter no. 5657 dtd. 23.03.2017 & L.No. 106 dated 04.04.2017 for Sand Quarry (opencast manual method) in an area of 14.430 ha. for production capacity of 75,000 cum/year at Khasra No.-149/1/1, Village-Jalkota, Tehsil-Maheshwar, District Khargone (M.P.) is hereby transferred to Sarpanch, Gram Panchayat, Jalkota, District Khargone (M.P.) on the same terms & conditions and validity period under which the prior environmental clearance was initially granted.
