The case was discussed in 606th SEIAA meeting dated 19.03.2020 and it has been recorded that.....

- (1) It was noted that the PP had applied in Form-IM in DEIAA, Burhanpur (44/2018) for Prior Environmental Clearance of Black Granite Quarry (Opencast Manual /Semi Mechanized Method) in an area of 2.00 ha. for production capacity of 863 cum/year at Khasra No.-67, Vill.-Dabali Khurd, Teh.-Nepanagar, District Burhanpur (MP) by Shri Rishab Chauhan,S/o Shri Vinod Singh, R/o Contractor Colony, Ward no, 3, Pandhar Area, Nepanagar, District-Burhanpur (MP).
- (2) The Prior Environmental Clearance letter was issued DEIAA, Burhanpur (44/2018) vide L.No. 4383/ DEIAA/18 dated 13.07.2018 in the name of Shri Rishab Chauhan, S/o Shri Vinod Singh, R/o Contractor Colony, Ward no, 3, Pandhar Area, Nepanagar, District-Burhanpur (MP ".
- (3) It is noted that PP has requested vide no Nil dtd.07.03.2020 received in SEIAA Office 12.03.2020 to make amendment in the Prior EC letter by changing the name of PP of the mining project namely " M/s Nepa Galaxy Mines, Partner Shri Rajeev Ranjan Sinha, Add. A-322 Mahalakshmi Nagar Indore,M.P. 452010" in place of " Shri Rishab Chauhan,S/o Shri Vinod Singh, R/o Contractor Colony, Ward no, 3, Pandhar Area, Nepanagar, District-Burhanpur (MP)...
- (4) It is noted that in support of his request the PP has submitted the following documents
 - No objection letter of previous Project Proponent (to whom prior EC was granted) for transfer of prior EC in the name of M/s Nepa Galaxy Mines, Partner Shri Rajeev Ranjan Sinha, Add. A-322 Mahalakshmi Nagar Indore, M.P. - 452010.
 - ii. Notarised affidavit of Shri Rishab Chauhan,S/o Shri Vinod Singh, R/o Contractor Colony, Ward no, 3, Pandhar Area, Nepanagar, District-Burhanpur (MP) mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.
 - iii. Copy of Lease Agreement
 - iv. Copy of Prior EC issued by DEIAA, Burhanpur (44/2018) vide L.No. 4383/ DEIAA/18 dated 13.07.2018
 - V. Copy of Lease transfer order issued by Office of Collector (Mining Division) to M/s Nepa Galaxy Mines, Partner Shri Rajeev Ranjan Sinha, Add. A-322 Mahalakshmi Nagar Indore, M.P. – 452010 vide letter No. 435 dated 09.09.2019.
- (5) It is noted that in EIA Notification 2006 as per Para-11 Transferability of Environmental Clearance (EC) there is a provision of transferring the EC.

Para-11:- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the

transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued by DEIAA, Burhanpur (44/2018) vide L.No. 4383/ DEIAA/18 dated 13.07.2018 in the name of " Shri Rishab Chauhan, S/o Shri Vinod Singh, R/o Contractor Colony, Ward no, 3, Pandhar Area, Nepanagar, District-Burhanpur (MP)" is hereby transferred to " M/s Nepa Galaxy Mines, Partner Shri Rajeev Ranjan Sinha, Add. A-322 Mahalakshmi Nagar Indore, M.P. - 452010." for Black Granite Quarry (Opencast Manual /Semi Mechanized Method) in an area of 2.00 ha. for production capacity of 863 cum/year at Khasra No.-67, Vill.-Dabali Khurd, Teh.-Nepanagar, District Burhanpur (MP)on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. All concerned be informed accordingly.
