- (1) It was noted that the PP had applied in Form-I M (DEIAA) (36/2018) for Prior Environmental Clearance of 4.940 ha. for production capacity of 23310 cum/year at khasra no. 31, 79,116 at Village-Arthi, Tehsil-Katthiwada, District- Alirajpur (MP) by Sarpanch, Gram Panchayat Guda, Tehsil- Katthiwada, District- Alirajpur (MP).
- (2) The Prior Environmental Clearance letter was issued by DEIAA, Alirajpur (36/2018) M.P. vide L.No. 332, dtd 09.07.2018, Sarpanch, Gram Panchayat Guda, Tehsil- Katthiwada, District-Alirajpur (MP)".
- (3) It is noted that PP has requested vide letter no. nil dtd. 09.03.2020 received in SEIAA Office dtd. 12.03.2020 to make amendment in the Prior EC letter by changing the name of PP of the mining project namely Shri Virendra Singh Jadoun, E-7/ M-708, Arera Colony, Bhopal M.P. 462016 in place of Sarpanch, Gram Panchayat Guda, Tehsil- Katthiwada, District- Alirajpur (MP)...
- (4) It is noted that in support of his request the PP has submitted the following documents:
 - No objection letter of previous Project Proponent (to whom prior EC was granted) for transfer of prior EC in the name of Shri Virendra Singh Jadoun, E-7/ M-708, Arera Colony, Bhopal M.P. 462016.

Janpad Panchyat Guda, Tehsil- Katthiwada, District- Alirajpur, mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.

- (5) It is noted that in EIA Notification 2006 as per Para-11 Transferability of Environmental Clearance (EC) there is a provision of transferring the EC.
 - Para-11:- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity

In context of above, it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued DEIAA, (36/2018) Alirajpur MP on 09.07.2018 in the name of "Sarpanch, Gram Panchayat, Guda, Tehsil- Katthiwada, District-Alirajpur." is hereby transferred to "Shri Virendra Singh Jadoun, E-7/ M-708, Arera Colony, Bhopal M.P. 462016" for Sand Quarry (Open cast manual method) in an area of 4.940 ha. for production capacity of 23310 cum/year at khasra no. 31, 79,116 at Village-Arthi, Tehsil-Katthiwada, District-Alirajpur (MP) .on the same terms & conditions and validity period under which the prior Environmental Clearance was initially granted.
