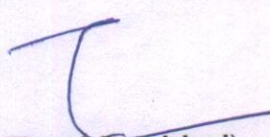
- (1) It was noted that the PP had applied in Form-IM in DEIAA (Case no. 116/2018) for Prior Environmental Clearance of 4.50 ha. for production capacity of 1,200 cum/year at Khasra No. 1039 at Village- Meriya Kheri, Tehsil - Sitamau, Dist. Mandsaur (MP) by Sarpanch/ Sachiv, Gram Panchayat Meriya Kheri , Tehsil Sitamau, Dist. Mandsaur (MP)..
- (2) The Prior Environmental Clearance letter was issued DEIAA vide L.No. 48/DEIAA/2018 dated 24.09.2018 in the name of " Sarpanch/ Sachiv, Gram Panchayat Meriya Kheri , Tehsil Sitamau, Dist. Mandsaur (MP)."
- (3) It is noted that PP has requested vide .L no nil dtd. 23.03.2020 received in SEIAA Office dtd. 11.05.2020 to make amendment in the Prior EC letter by changing the name of PP of the mining project namely " **M/s Maa Bhagwati Construction Chandwasa, Prop. Shri Govind Singh, House No. 23, Kilagari, Tehsil Shamgarh, Dist. Mandsaur M.P- 458883** in place of Sarpanch/ Sachiv, Gram Panchayat Meriya Kheri , Tehsil Sitamau, Dist. Mandsaur (MP)
- (4) It is noted that in support of his request the PP has submitted the following documents
 - i. No objection letter of previous Project Proponent (to whom prior EC was granted) for transfer of prior EC in the name of **M/s Maa Bhagwati Construction Chandwasa, Prop. Shri Govind Singh, House No. 23, Kilagari, Tehsil Shamgarh, Dist. Mandsaur M.P- 458883.**
 - ii. **Notarised affidavit of CEO- Shri Govardhan Lal Malviya, Janpad Panchyat Sitamau, Dist. Mandsaur.**" mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.
 - iii. Copy of Prior EC issued by DEIAA, vide L.No. 48/DEIAA/2018 dated 24.09.2018 in the name of Sarpanch/ Sachiv, Gram Panchayat Meriya Kheri , Tehsil Sitamau, Dist. Mandsaur (MP).
 - iv. Copy of Environmental Management Plan of **M/s Maa Bhagwati Construction Chandwasa, Prop. Shri Govind Singh, House No. 23, Kilagari, Tehsil Shamgarh, Dist. Mandsaur M.P- 458883**
 - v. Copy of Mining Plan & Replenishment Plan transfered to **M/s Maa Bhagwati Construction Chandwasa, Prop. Shri Govind Singh, House No. 23, Kilagari, Tehsil Shamgarh, Dist. Mandsaur M.P- 458883**
 - vi. Lease transfer order issued by Mineral Resource Department order to **M/s Maa Bhagwati Construction Chandwasa, Prop. Shri Govind Singh, House No. 23, Kilagari, Tehsil Shamgarh, Dist. Mandsaur M.P- 458883** vide.letter No. 922/132/2020/12/1 dated 18.02.2020.

- (5) It is noted that in EIA Notification 2006 as per **Para-11 Transferability of Environmental Clearance (EC)** there is a provision of transferring the EC.

Para-11 :- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued by DEIAA, Tikamgarh (Case no. 116/2018) on 24.09.2018 in the name of "Sarpanch/ Sachiv, Gram Panchayat Meriya Kheri, Tehsil Sitamau, Dist. Mandsaur (MP)." is hereby transferred to "M/s Maa Bhagwati Construction Chandwasa, Prop. Shri Govind Singh, House No. 23, Kilagari, Tehsil Shamgarh, Dist. Mandsaur M.P- 458883 " for Sand Quarry (Open cast manual method) in an area of 4.50 ha. for production capacity of 1,200 cum/year at Khasra No. 1039 at Village- Meriya Kheri, Tehsil - Sitamau, Dist. Mandsaur (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. **All concerned be informed accordingly.**

Hence, the Prior Environmental Clearance issued to Sarpanch/ Sachiv, Gram Panchayat Karandiya, Tehsil Sitamau, Dist. Mandsaur. DEIAA (Case no. 116/2018) vide L.No. 48/DEIAA/2018 dated 24.09.2018 for Sand Quarry (Open cast manual method) in an area of 4.50 ha. for production capacity of 1,200 cum/year at Khasra No. 1039 at Village- Meriya Kheri, Tehsil - Sitamau, Dist. Mandsaur (MP) is hereby transferred to **M/s Maa Bhagwati Construction Chandwasa, Prop. Shri Govind Singh, House No. 23, Kilagari, Tehsil Shamgarh, Dist. Mandsaur M.P- 458883.** on the same terms & conditions and validity period under which the prior environmental clearance was initially granted.

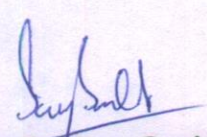
