It was noted that the PP had applied in Form-IM in DEIAA (Case no. 2837/2015) for Prior (1) Environmental Clearance of 3.00 ha. for production capacity of 18,838 cum/year at Khasra No. 45 at Village- Dantgora, Tehsil - Palera, Dist. Tikamgarh (MP) by The M.P. State Mining Corporation Ltd., Sub Off., Tikamgarh (MP).

The Prior Environmental Clearance letter was issued DEIAA vide L.No. 13/DEIAA/2016 dated (2) 26.05.2016 in the name of "The M.P. State Mining Corporation Ltd., Sub Off., Tikamgarh (MP)."

- It is noted that PP has requested vide .L no nil dtd. nil received in SEIAA Office dtd. 22.05.2020 to (3) make amendment in the Prior EC letter by changing the name of PP of the mining project namely " Shri Virendra Singh Jadoun, E-7/ M-708, Arera Colony, Bhopal M.P. 462016 in place of The M.P. State Mining Corporation Ltd., Sub Off., Tikamgarh (MP).
- It is noted that in support of his request the PP has submitted the following documents (4)
 - No objection letter of previous Project Proponent (to whom prior EC was granted) for i. transfer of prior EC in the name of Shri Virendra Singh Jadoun, E-7/ M-708, Arera Colony, Bhopal M.P. 462016.
 - Notarised affidavit of of Shri Nagendra Singh, OIC, M.P. State Mining Corporation ii. Ltd." mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.
 - Copy of Prior EC issued by DEIAA, vide L.No. 13 DEIAA/2016 dated 26.05.2016 in the iii. name of The M.P. State Mining Corporation Ltd., Sub Off., Tikamgarh (MP).
 - Copy of Environmental Management Plan of Shri Virendra Singh Jadoun, E-7/ M-708, iv. Arera Colony, Bhopal M.P. 462016
 - Copy of Mining Plan & Replenishment Plan transfered to Shri Virendra Singh Jadoun, V. E-7/ M-708, Arera Colony, Bhopal M.P. 462016.
 - Lease transfer order issued by Mineral Resource Department order to Shri Virendra vi. Singh Jadoun, E-7/ M-708, Arera Colony, Bhopal M.P. 462016 vide endt.letter No. 1582/132/2020/12/1 dated 13.03.2020.

- It is noted that in EIA Notification 2006 as per Para-11 Transferability of Environmental Clearance (5) (EC) there is a provision of transferring the EC.
 - Para-11 :- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued by DEIAA, Tikamgarh (Case no. 2837/2015) on 26.05.2016 in the name of " The M.P. State Mining Corporation Ltd., Sub Off., Tikamgarh (MP)." is hereby transferred to "Shri Virendra Singh Jadoun, E-7/ M-708, Arera Colony, Bhopal M.P. 462016". for Sand Quarry (Open cast manual method) in an area of 3.00 ha. for production capacity of 18,838 cum/year at Khasra No. 45 at Village- Dantgora, Tehsil - Palera, Dist. Tikamgarh (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. All concerned be informed accordingly.
