The case was discussed in 614th SEIAA meeting dtd 04.06.20 and it has been recorded that

Applicant M/s Sainik Industries Pvt. Ltd., Authorized person Shri Litesh Jha, 201-202, Vikas Plaza Building No. 2, Local Shopping Center Kalkaji New Delhi-110019 has submitted the following documents in support of his request:

- g) Lease transfer order issued by Mineral Resource Department to M/s Sainik Industries Pvt.Ltd., Authorized person Shri Litesh Jha, 201-202, Vikas Plaza Building No. 2, Local Shopping Center Kalkaji New Delhi-110019 vide letter No. 1660/132/2020/12/1/ dated 16.03.2020.

As per the notification issued by MoEF&CC on 14.09.2006, the policy on transferability of EC is as follows:-

Para 11. Transferability of Environmental Clearance (EC):

A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

After detailed discussions on the MoEF&CC Notification regarding transferability and perusal of the above information, it has been decided to transfer the Prior EC issued on 04.08.18 in favour of M/s Sainik Industries Pvt. Ltd., Authorized person Shri Litesh Jha, 201-202, Vikas Plaza Building No. 2, Local Shopping Center Kalkaji New Delhi-110019 in the place of Sarpanch, Gram Panchayat Pepkhara, Tehsil - Rampur Naikin, Dist. - Sidhi (MP) for Sand Quarry in an area of 4.680 ha. for production capacity of 42120 cum/year at khasra no. 404, 1215 at Village - Bajranggarh, Tehsil - Rampur Naikin, Dist. - Sidhi (MP) on the same terms & conditions and validity period under which the prior Environmental Clearance was initially granted. Copy to PP and all concerned".

Hence, it was decided to transfer the Prior EC in the name of M/s Sainik Industries Pvt. Ltd., Authorized person Shri Litesh Jha, 201-202, Vikas Plaza Building No. 2, Local Shopping Center Kalkaji New Delhi-110019 with the same terms & conditions under which the Prior Environmental Clearance was initially granted, and for the same production capacity and validity period.
