The case was discussed in 653<sup>rd</sup> SEIAA meeting dtd. 08.01.2021 and it was recorded that.....

- (1) It was noted that the PP had applied in Form-IM in DEIAA (Case no. 70/2017) for Prior Environmental Clearance for Sand Quarry in an area of 5.0 ha. for production capacity of 1200 cum/ year at Khasra No. 197, 110 at Village Chhaprat, Tehsil Patharia, Dist. Damoh (MP) by Sarpanch Gram Panchayat, Hinota, Tehsil Patharia, District -Damoh.
- (2) The Prior Environmental Clearance letter was issued DEIAA vide L.No. 287/DEIAA/18 dtd.20.04.2018 in the name of " Sarpanch Gram Panchayat , Hinota, Tehsil Patharia, District -Damoh".
- (3) As per Collector (LoI) Letter no. 221 dtd. 06.05.2017 the lease validity is upto 31.03.2022
- (4) It is noted that PP has requested vide no nil dtd.nil received in SEIAA office 15.12.2020 to make amendment in the Prior EC letter by changing the name of PP of the mining project namely " M/s Musa Construction, Shri Murim Ajam Khan(Owner), 232 Tas Mesco School, Naya Bazar No. 2, Damoh khas, Dist. Damoh, MP 470661" in place of "Sarpanch Gram Panchayat, Hinota, Tehsil Patharia, District -Damoh "...".
- (5) It is noted that in support of his request the PP has submitted the following documents.
  - Notarised affidavit / No objection letter of previous Project Proponent (to whom prior EC was granted) issued by CEO, Janpad Panchyat, Patharia, District Damoh MP for transfer of prior EC on behalf of "Sarpanch Gram Panchayat, Hinota, Tehsil – Patharia, District -Damoh" of prior EC in the name of M/s Musa Construction, Shri Murim Ajam Khan(Owner), 232 Tas Mesco School, Naya Bazar No. 2, Damoh khas, Dist. Damoh, MP - 470661
  - ii. Notarised affidavit of M/s Musa Construction, Shri Murim Ajam Khan(Owner), 232 Tas Mesco School, Naya Bazar No. 2, Damoh khas, Dist. Damoh, MP 470661".mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.

- (6)It is noted that in EIA Notification 2006 as per Para-11 Transferability of Environmental Clearance (EC) there is a provision of transferring the EC

Para-11 :- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued DEIAA on 20.04.2018 in the name of " Sarpanch Gram Panchayat , Hinota, Tehsil - Patharia, District -Damoh." is hereby transferred to "M/s Musa Construction, Shri Murim Ajam Khan(Owner), 232 Tas Mesco School, Naya Bazar No. 2, Damoh khas, Dist. Damoh, MP - 470661 " for Sand Quarry in an area of 5.0 ha. for production capacity of 1200 cum/ year at Khasra No. 197, 110 at Village - Chhaprat, Tehsil - Patharia, Dist. Damoh (MP) " on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. All concerned be informed accordingly.

Hence, the Prior Environmenal Clearance issued to "Sarpanch Gram Panchayat, Hinota, Tehsil -Patharia, District -Damoh ", DEIAA vide L.No. 287/DEIAA/18 dtd. 20.04.2018 for Sand Quarry in an area of 5.0 ha. for production capacity of 1200 cum/ year at Khasra No. 197, 110 at Village -Chhaprat, Tehsil - Patharia, Dist. Damoh (MP)." is hereby transferred to M/s Musa Construction, Shri Murim Ajam Khan(Owner), 232 Tas Mesco School, Naya Bazar No. 2, Damoh khas, Dist. Damoh, MP - 470661 on the same terms & conditions and validity period under which the prior environmental clearance was initially granted.
