- It was noted that the PP had applied in Form-IM in DEIAA (Case no. 64/2017) for Prior Environment (1) Clearance for Sand Quarry in an area of 5.0 ha. for production capacity of 1000 cum/ year at Khasra No. 1, 103 at Village - Barbansa, Tehsil - Damoh, Dist. Damoh (MP) by Sarpanch Gram Panchayat, Barbansa, Tehsil - Damoh, District -Damoh.
- The Prior Environmental Clearance letter was issued DEIAA vide L.No. 281/DEIAA/18 dtd.20.04.2018 (2)in the name of " Sarpanch Gram Panchayat , Barbansa, Tehsil - Damoh, District -Damoh".
- As per Collector (Lol) Letter no. 219 dtd. 06.05.2017 the lease validity is upto 31.03.2022 (3)

- (6)It is noted that in EIA Notification 2006 as per Para-11 Transferability of Environmental Clearance (EC) there is a provision of transferring the EC.

Para-11 :- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued DEIAA on 20.04.2018 in the name of " Sarpanch Gram Panchayat , Barbansa, Tehsil - Damoh, District -Damoh." is hereby transferred to "M/s Musa Construction, Shri Murim Ajam Khan(Owner), 232 Tas Mesco School, Naya Bazar No. 2, Damoh khas, Dist. Damoh, MP - 470661 " for Sand Quarry in an area of 5.0 ha. for production capacity of 1000 cum/ year at Khasra No. 1, 103 at Village - Barbansa, Tehsil - Damoh, Dist.
