- It was noted that the PP had applied in Form-I for Prior Environmental Clearance of 4.60ha. for production capacity of 50000 cum per annum at Khasra No. 536, 537/2 at Village -Shakarpur, Tehsil - Gwalior, Dist. Gwalior (MP) by M/s Ambica Stone Industries, Pro. Late Smt. Lata.Sharma W/o Shri Laxmi Narayan Sharma, Ramdas Ghati Near Kaila Devi Mandir, Shinde Ki Chawni, Gird, Dist. Gwalior, MP - 474001
- The Prior Environmental Clearance letter was issued DEIAA vide L.No. 308/DEIAA/N.K-(2) 1/2018 dtd. 5.10.2018 in the name of " M/s Ambica Stone Industries, Pro..Smt.Lata Sharma W/o Shri Laxmi Narayan Sharma, Ramdas Ghati Near Kaila Devi Mandir, Shinde Ki Chawni, Gird, Dist. Gwalior, MP - 474001.

Gwalior, MP - 474001." in place of M/s Ambica Stone Industries, Pro. Late Smt.Lata Sharma W/o Shri Laxmi Narayan Sharma, Ramdas Ghati Near Kaila Devi Mandir, Shinde Ki Chawni, Gird, Dist. Gwalior, MP - 474001. "
- It is noted that in support of his request the PP has submitted the following documents (4)
  - No objection letter of previous Project Proponent (to whom prior EC was granted) for transfer of prior EC in the name of M/s Ambica Stone Industries, Shri Vipin Sharma, Ramdas Ghati Near Kaila Devi Mandir, Shinde Ki Chawni, Gird, Dist. Gwalior, MP - 474001.
  - Notarised affidavit of M/s Ambica Stone Industries, Shri Laxmi Narayan ii. Sharma, W/o Late Smt. Lata Sharma Ramdas Ghati Near Kaila Devi Mandir, Shinde Ki Chawni, Gird, Dist. Gwalior, MP,".mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.

- (5) It is noted that in EIA Notification 2006 as per Para-11 Transferability of Environmental Clearance (EC) there is a provision of transferring the EC.
  - Para-11: A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued DEIAA on 5.10.2018 in the name of "M/s Ambica Stone Industries, Pro. Late Smt. Lata Sharma W/o Shri Laxmi Narayan Sharm R/o Ramdasghati Near Kaila Devi Mandir, Shinde Ki Chawni, Gird, Dist. Gwalior, MP – 474001 MP." is hereby transferred to M/s Ambica Stone Industries, Shri Vipin Sharma, Ramdasghati Near Kaila Devi Mandir, Shinde Ki Chawni, Gird, Dist. Gwalior, MP - 474001.for Stone Quarry in an area of 4.60ha. for production capacity of 50000 cum per annum at Khasra No. 536, 537/2 at Village - Shakarpur, Tehsil - Gwalior, Dist. Gwalior (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. All concerned be informed accordingly.
