Sub:- Case No 8337/2021, Prior Environment Clearance for Stone Quarry in an area of 4.0 ha for production capacity of 59971 cum per annum at Khasra No. 1309, 1314, 1324, 1379 at Village -Katheri, Tehsil - Sarai, Dist. - Singrauli (MP) by Shri Jai Singh S/o Shri Sher Singh R/o Chhilar, Tehsil - Charkhi Dadri, District - Bhiwani (Haryana).-Regarding transfer of EC in the name of M/s Shiv Shakti Construction, Shri Surendra Singh, Partner, Village - Kathari, Tehsil - Sarai, Dist. -Singrauli, MP - 486881.

The case was discussed in 669th SEIAA meeting dtd 26.03.2021 and it has been recorded that

- "....It is noted that the PP had applied in Form-7 for transfer of Prior Environmental Clearance for Stone Quarry in an area of 4.0 ha. for production capacity of 59971cum/year at Khasra no. 1309, 1314, 1324, 1379 at Village - Katheri, Tehsil - Sarai, Dist.- Singrauli (MP) by M/s Shiv Shakti Construction, Shri Surendra Singh, Partner, Village - Kathari, Tehsil - Sarai, Dist. - Singrauli, MP - 486881
- 1. The Prior Environmental Clearance letter was issued by DEIAA vide L.No 113 /DEIAA/ Parva. Anumati/ 2016 dated 24.08.16 in the name of Shri Jai Singh S/o Shri Sher Singh R/o Chhilar, Tehsil - Charkhi Dadri, District - Bhiwani (Haryana).
- 2. It is noted that in support of his request the PP has submitted the following documents::

No Objection Certificate in the form of Notarised Affidavit submitted by M/s Shiv Shakti Construction, Shri Surendra Singh, Partner, Village - Kathari, Tehsil - Sarai, Dist. - Singrauli, MP - 486881 mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued
  - ii. Notarised affidavit of M/s Shiv Shakti Construction, Shri Surendra Singh, Partner, Village -Kathari, Tehsil - Sarai, Dist. - Singrauli, MP - 486881 mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued..
  - iii. Copy of Prior EC issued by DEIAA L.No 113/DEIAA/Parya. Anumati/ 2016 dated 24.08.16.
  - iv. Copy of Environmental Management Plan of M/s Shiv Shakti Construction, Shri Surendra Singh, Partner, Village - Kathari, Tehsil - Sarai, Dist. Singrauli, MP - 486881.
  - v. Copy of Approved Mining Plan of M/s Shiv Shakti Construction, Shri Surendra Singh, Partner, Village - Kathari, Tehsil - Sarai, Dist. - Singrauli (MP).

- Lease transfer order issued by Office of Collector (Mining Division), Singrauli to M/s Shiv Shakti Construction, Shri Surendra Singh (Partner), Village - Kathari, Tehsil - Sarai, Dist. – Singrauli vide letter No. 2034/Khanij/QL/Hastan./ 2017 dated 13.06.2017.
- 3. As per the notification issued by MoEF&CC on 14.09.2006, the policy on transferability of EC is as follows:-
- 11. Transferability of Environmental Clearance (EC):

A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases

In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued on 24.08.16 in the name of "Shri Jai Singh s/o Shri Sher Singh R/o Chhilar, Tehsil – Charkhi Dadri, District – Bhiwani (Haryana) is hereby transferred to M/s Shiv Shakti Construction, Shri Surendra Singh, Partner, Village - Kathari, Tehsil- Sarai, Dist. - Singrauli, MP – 486881 (MP) for Stone Quarry in an area of 4.0 ha for production capacity of 59971 cum per annum at Khasra No. 1309, 1314, 1324, 1379 at Village - Katheri, Tehsil - Sarai, Dist. Singrauli (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. All concerned be informed accordingly

Hence, it was decided to transfer the Prior EC in the name of M/s Shiv Shakti Construction, Shri Surendra Singh, Partner, Village - Kathari, Tehsil- Sarai, Dist. - Singrauli, MP - 486881 (MP) with the same terms & conditions under which the Prior Environmental Clearance was initially granted, and for the same production capacity and validity period.
