The case was discussed in 670th SEIAA meeting dtd 27.03.2021 and it has been recorded that

- "...It is noted that the PP had applied in Form-7 for transfer of Prior Environmental Clearance for Stone Quarry in an area of 3.935 ha. for production capacity of 45600 cum per annum at Khasra No. 196/2/2/1, 196/2/2/2, 192 at Village Samnapurkalan, Tehsil Gouharganj, Dist. Raisen (MP) by M/s Dilip Metal, Shri Satyendra Pandey, Ward No. 4, Near Raj Medical, First Floor, Main Road, Obedullaganj, Tehsil Gouharganj, Dist. Raisen, MP 464990.
- The Prior Environmental Clearance letter was issued by DEIAA vide L.No337/DEIAA/2018 dated 26.03.18 in the name of Shri Pankaj Kothari S/o Shri Vijay Kothari R/o Kothari Bhavan, Station Road Obedullaganj, District Raisen (MP).

As per the notification issued by MoEF&CC on 14.09.2006, the policy on transferability of EC is as follows:-

11. Transferability of Environmental Clearance (EC):

A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases

In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued by DEIAA on 26.03.18 in the name of " Shri Pankaj Kothari S/o Shri Vijay Kothari R/o Kothari Bhavan, Station Road Obedullaganj, District Raisen (MP) is hereby transferred to M/s Dilip Metal, Shri Satyendra Pandey, Ward No. 4, Near Raj Medical, First Floor, Main Road, Obedullaganj, Tehsil - Gouharganj, Dist. Raisen, MP - 464990 for Stone Quarry in an area of 3.935 ha. for production capacity of 45600 cum per annum at Khasra No. 196/2/2/1, 196/2/2/2, 192 at Village - Samnapurkalan, Tehsil - Gouharganj, Dist. Raisen (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. All concerned be informed accordingly.

Hence, it was decided to transfer the Prior EC in the name of M/s Dilip Metal, Shri Satyendra Pandey, Ward No. 4, Near Raj Medical, First Floor, Main Road, Obedullaganj, Tehsil - Gouharganj, Dist. Raisen, MP – 464990 with the same terms & conditions under which the Prior Environmental Clearance was initially granted, and for the same production capacity and validity period.
