Sub:- Case No. 2881/2015: Prior Environmental Clearance for Sand Quarry (opencast manual method) in an area of 0.405 ha. for production capacity of 12150 cum/year at Khasra no.-317, at Village- Sivani, Tehsil-Bareli, District-Raisen (MP) by Shri Rajendra Raghuwanshi, R/o D-4, Phase-2, Shri Ram Colony, Hoshangabad Road, Dist. Bhopal, MP,

The Case was discussed in 606th SEIAA meeting dated 19.03.2020 and it has been recorded that.....

- It was noted that the PP had applied in Form-I for Prior Environmental Clearance of 0.405 ha. for production capacity of 12150 cum/year at Khasra no.-317, at Village- Sivani, Tehsil-Bareli, District-Raisen (MP) by Sarpanch Gram Panchyat Barhakalan, Dist-Raisen MP.
- (2) The Prior Environmental Clearance letter was issued SEIAA vide L.No. 27/ SEIAA/19 dtd.1.4.2019 in the name of "Sarpanch Gram Panchyat Barhakalan, Dist-Raisen MP
- (3) It is noted that PP has requested vide no Nil dtd.12.3.2020 to make amendment in the Prior EC letter by changing the name of PP of the mining project namely "Shri Rajendra Raghuwanshi, R/o D-4, Phase-2, Shri Ram Colony, Hoshangabad Road, Dist. Bhopal, MP." in place of Sarpanch Gram Panchyat Barhakalan, Dist-Raisen MP. "
- (4) It is noted that in support of his request the PP has submitted the following documents
  - No objection letter of previous Project Proponent (to whom prior EC was granted) for transfer of prior EC in the name of Shri Rajendra Raghuwanshi, R/o D-4, Phase-2, Shri Ram Colony, Hoshangabad Road, Dist. Bhopal, MP.
  - Notarised affidavit of CEO, Janpad Panchayat Badi, Dist-Raisen MP".mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.
  - iii. Copy of Prior EC issued by SEIAA vide letter No. 27/SEIAA/19 dtd.1.4.2019.
  - iv. Copy of Environmental Management Plan of Shri Rajendra Raghuwanshi, R/o D-4, Phase-2, Shri Ram Colony, Hoshangabad Road, Dist. Bhopal, MP.
  - Copy of Approved Mining Plan with Replenishment Plan of Shri Rajendra Raghuwanshi, R/o D-4, Phase-2, Shri Ram Colony, Hoshangabad Road, Dist. Bhopal, MP.
  - Lease transfer order issued by Mineral Resource Department order to Shri Rajendra vi. Raghuwanshi, R/o D-4, Phase-2, Shri Ram Colony, Hoshangabad Road, Dist. Bhopal, MP.vide letter No. 1313/132/2020/12/1 dated 4.3.2020.
- It is noted that in EIA Notification 2006 as per Para-11 Transferability of Environmental Clearance (EC) there is a provision of transferring the EC.
  - Para-11 :- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued SEIAA on 1.4.2019 in the

name of "Sarpanch Gram Panchyat Barhakalan, Dist-Raisen MP." is hereby transferred to Shri Rajendra Raghuwanshi, R/o D-4, Phase-2, Shri Ram Colony, Hoshangabad Road, Dist. Bhopal, MP.for Sand Quarry in an area of 0.405 ha. for production capacity of 12150 cum/year at Khasra no.-317, at Village-Sivani, Tehsil-Bareli, District-Raisen (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. All concerned be informed accordingly.

Bhopal, MP.for Sand Quarry in an area of 0.405 ha. for production capacity of 12150 cum/year at Khasra no.-317, at Village- Sivani, Tehsil-Bareli, District-Raisen (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted.
