Sub:- Case no. 2926/2015 Prior Environmental Clearance for Sand Quarry in an area of 10.00 ha. for production capacity of 1,80,000 cum/year (as per approved Mining and Replenishment Plan) at khasra no. 691/1 at Village-Jasalpur-1, Tehsil- Hoshangabad, District-Hoshangabad (MP) by M/s R.K. Transport & Constructions Ltd., 65 - A Transport Nagar Korba Distt. - Korba, (C.G).

The case was discussed in 652nd SEIAA meeting dtd 30.12.20 and it has been recorded that

"The Prior EC was issued by SEIAA to Shri Raj Kumar Nema, OIC, Sub Off., M.P. State Mining Corporation Ltd., H.No. 12, Ward No. 17, Sainath Colony, Meenakshi, Hoshangabad (MP)-461001 vide Letter No. 803/SEIAA/16 dated 20.04.16 for an area of 10.00 ha. (2,50,000 cum/year) at khasra no. 691/1 at Village-Jasalpur-1, Tehsil-Hoshangabad, District-Hoshangabad (MP)".

Applicant M/s R.K. Transport & Constructions Ltd., 65 - A Transport Nagar Korba Distt. - Korba, (C.G) has submitted the following documents in support of his request:

- No objection letter (in form of affidavit) of Shri Rajkumar Nema, OIC, M.P. State Mining Corporation Ltd as previous Project Proponent (to whom prior EC was granted) for transfer of prior EC in the name of M/s R.K. Transport & Constructions Ltd., 65 - A Transport Nagar Korba Distt. - Korba, (C.G).
- ii. No objection letter received from main leasee, MPSMC vide letter dated 30.12.2020 mentioning that the contractor has surrendered mining lease to MPSMC vide letter dated 31.01.2020 but the MPSMC has Sand Mining Lease validity upto 03.04.2022 as per collector letter no. 65/Khanij/2012 dated 23.01.2012.
- iii. Notarised affidavit of M/s R.K. Transport & Constructions Ltd., 65 A Transport Nagar Korba Distt. - Korba, (C.G) mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.
- iv. Copy of Prior EC issued by SEIAA vide letter No. 803/SEIAA/16 dated 20.04.16.
- v. Copy of Environmental Management Plan of M/s R.K. Transport & Constructions Ltd., 65 A Transport Nagar Korba Distt. Korba, (C.G).
- vi. Copy of Approved Mining Plan with Replenishment Plan of M/s R.K. Transport & Constructions Ltd., 65 A Transport Nagar Korba Distt. Korba, (C.G).

vii. Lease transfer order issued by Mineral Resource Department to M/s R.K. Transport & Constructions Ltd., 65 - A Transport Nagar Korba Distt. - Korba, (C.G) vide letter No. 5533/132/2020/12/1 dated 16.12.2020 and 5696/132/2020/12/1 dated 25.12.2020.

As per the notification issued by MoEF&CC on 14.09.2006, the policy on transferability of EC is as follows:-

Para 11. Transferability of Environmental Clearance (EC):

A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

After detailed discussions on the MoEF&CC Notification regarding transferability and perusal of the above information, it has been decided to transfer the Prior EC issued by SEIAA, MP on 20.04.2016 in the name of "Shri Raj Kumar Nema, OIC, Sub Off., M.P. State Mining Corporation Ltd., H.No. 12, Ward No. 17, Sainath Colony, Meenakshi, Hoshangabad (MP)-461001" is hereby transferred to "M/s R.K. Transport & Constructions Ltd., 65 - A Transport Nagar Korba Distt. - Korba, (C.G)" for Sand Quarry in an area of 10.00 ha. for production capacity of 1,80,000 cum/year (as per approved Mining and Replenishment Plan) at khasra no. 691/1 at Village-Jasalpur-1, Tehsil- Hoshangabad, District-Hoshangabad (MP) on the same terms & conditions and validity period under which the prior Environmental Clearance was initially granted. Copy to PP and all concerned".

Hence, it was decided to transfer the Prior EC in the name of M/s R.K. Transport & Constructions Ltd., 65 - A Transport Nagar Korba Distt. - Korba, (C.G) with the same terms & conditions under which the Prior Environmental Clearance was initially granted, and for the same production capacity and validity period.
