"The Prior EC was issued by SEIAA to Shri Suresh Kumar Dubey, OIC, M.P. State Mining Corporation Ltd., Vanshroop Ward, Bhatatha Mohalla, Katni (MP) vide Letter No. 7021/SEIAA/15 dated 31.10.15 for an area of 15.00 ha. (1,20,000 cum/year) at khasra no. 358 at Village - Paraswara, Tehsil - Barhi, District - Katni (MP)".

As per the notification issued by MoEF&CC on 14.09.2006, the policy on transferability of EC is as follows:-

Para 11. Transferability of Environmental Clearance (EC):

A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

After detailed discussions on the MoEF&CC Notification regarding transferability and perusal of the above information, it has been decided to transfer the Prior EC issued on 31.10.2015 in favour of M/s Vista Sales Pvt. Ltd., Gala no. 216, Building no. 03 B, Rahul Mittal Industries State Kurla Road, Andheri Mumbai - 400059 (MH) in the place of Shri Suresh Kumar Dubey, OIC, M.P. State Mining Corporation Ltd., Vanshroop Ward, Bhatatha Mohalla, Katni (MP) for Sand Quarry in an area of 15.0 ha. for production capacity of 1,20,000 cum/year at khasra no. 358 at Village - Paraswara, Tehsil - Barhi, District - Katni (MP) on the same terms & conditions and validity period under which the prior Environmental Clearance was initially granted".

Hence, it was decided to transfer the Prior EC in the name of M/s Vista Sales Pvt. Ltd., Gala no. 216, Building no. 03 B, Rahul Mittal Industries State Kurla Road, Andheri Mumbai - 400059 (MH) with the same terms & conditions under which the Prior Environmental Clearance was initially granted, and for the same production capacity and validity period.
