- It was noted that the PP had applied in Form-I for Prior Environmental Clearance of 5.666 ha. for production capacity of 43,000 cum/year at khasra no. 01 at Village-Saipura, Tehsil-Palera, District-Tikamgarh (MP) by Shri Kailash Chandra Gupta, M/s Shiva Corporation India Pvt. Ltd., 312, Ganpati Plaza, MIG Road, District-Jaipur (Raj.).
- The Prior Environmental Clearance letter was issued SEIAA vide L.No. 1993/SEIAA/16 dtd.14.06.2016 in the name of " Shri Kailash Chandra Gupta, M/s Shiva Corporation India Pvt. Ltd., 312, Ganpati Plaza, MIG Road, District-Jaipur (Raj.).
- It is noted that PP has requested vide no nil dtd.nil received in SEIAA office 12.03.2020 to make amendment in the Prior EC letter by changing the name of PP of the mining project namely " Shri Virendra Singh Jadon, E-7/ M-708, Arera Colony, Bhopal M.P. 462016." in place of "Shri Kailash Chandra Gupta, M/s Shiva Corporation India Pvt. Ltd., 312, Ganpati Plaza, MIG Road, District-Jaipur (Raj.)".
- It is noted that in support of his request the PP has submitted the following documents

It is noted that in EIA Notification 2006 as per Para-11 Transferability of Environmental Clearance (EC) there is a provision of transferring the EC.

> Para-11 :- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued SEIAA on 14.06.2016 in the name of "Shri Kailash Chandra Gupta, M/s Shiva Corporation India Pvt. Ltd., 312, Ganpati Plaza, MIG Road, District-Jaipur (Raj.)." is hereby transferred to Shri VIrendra Singh Jadon, E-7/ M-708, Arera Colony, Bhopal M.P. 462016 " for Sand Quarry (Open cast manual method) in an area of 5.666 ha. for production capacity of 43,000 cum/year at khasra no. 01 at Village-Saipura, Tehsil-Palera, District-Tikamgarh (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. All concerned be informed accordingly.

In view of above, prior EC issued to Sarpanch Gram Panchyat Aliganj, Tehsil- -Bareli, District-Raisen by SEIAA vide letter No. 1993/ SEIAA/16 dtd.14.6.2016 is hereby transferred to Shri Virendra Singh Jadon, E-7/ M-708, Arera Colony, Bhopal M.P. 462016 for Sand Quarry (Open cast manual method) in an area of 5.666 ha. for production capacity of 43,000 cum/year at khasra no. 01 at Village-Saipura, Tehsil-Palera, District-Tikamgarh (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted.
