It was noted that the PP had applied in Form-I for Prior Environmental Clearance of 15.00 ha. for (1) production capacity of 75,000 cum/year at Khasra no.-149/1/1 at Village-Jalkota, Tehsil-Maheshwar, District-Khargone (MP) by Sarpanch, Gram Panchayat, Jolkota, Tehsil-Maheshwar District - Khargone

The Prior Environmental Clearance letter was issued by SEIAA, M.P. vide L.No. 139, dtd (2) 02.05.2018.2018, Sarpanch, Gram Panchayat, Jolkota, Tehsil-Maheshwar District - Khargone

(5) It is noted that in EIA Notification 2006 as per Para-11 Transferability of Environmental Clearance (EC) there is a provision of transferring the EC.

Para-11:- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

In context of above, it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued by SEIAA, MP on 02.05.2018 in the name of "Sarpanch, Gram Panchayat, Jolkota, Tehsil-Maheshwar District – Khargone (MP)." is hereby transferred to "R.K.Gupta Contractors and Engineers Private Ltd.
