"The Prior EC was issued by SEIAA, vide L.No. 21/SEIAA/18 dated 04.04.18 in the name of Sarpanch, Gram Panchayat, New Chargwan, Dist. - Jabalpur (MP) for an area of 13.370 ha. for production capacity of 25,000 cum/year at khasra no. 414 at Village - New Chargwan, Tehsil - Shahpura, Dist. - Jabalpur (MP)".

Applicant Aaradhya Logistic Solution Pvt. Ltd., Authorized Person - Shri Brajesh Sohaney, 1967, Right Town, Jabalpur, MP - 482001 has submitted the following documents in support of his request:

g) Lease transfer order issued by Mineral Resource Department to Aaradhya Logistic Solution Pvt. Ltd., Authorized Person – Shri Brajesh Sohaney, 1967, Right Town, Jabalpur, MP – 482001 vide letter No. 1535/132/2020/12/1/ dated 12.03.2020.

As per the notification issued by MoEF&CC on 14.09.2006, the policy on transferability of EC is as follows:-

Para 11. Transferability of Environmental Clearance (EC):

A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

After detailed discussions on the MoEF&CC Notification regarding transferability and perusal of the above information, it has been decided to transfer the Prior EC issued by SEIAA on 04.04.18 in the name of "Sarpanch, Gram Panchayat, New Chargwan, Dist. - Jabalpur (MP)" is hereby transferred to "Aaradhya Logistic Solution Pvt. Ltd., Authorized Person – Shri Brajesh Sohaney, 1967, Right Town, Jabalpur, MP – 482001" for Sand Quarry in an area of 13.370 ha. for production capacity of 25,000 cum/year at khasra no. 414 at Village - New Chargwan, Tehsil - Shahpura, Dist. - Jabalpur (MP) on the same terms & conditions, production capacity and validity period under which the prior Environmental Clearance was initially granted".

Hence, it was decided to transfer the Prior EC in the name of Aaradhya Logistic Solution Pvt. Ltd., Authorized Person – Shri Brajesh Sohaney, 1967, Right Town, Jabalpur, MP – 482001 with the same terms & conditions under which the Prior Environmental Clearance was initially granted, and for the same production capacity and validity period.
