
The case was discussed in 606th SEIAA meeting dated 19.03.2020 and it has been recorded that.....

- (1) It was noted that the PP had applied in Form-I for Prior Environmental Clearance of 23.0 ha. for production capacity of 57,500 cubic meter per year at Khasra no.-173, 174 at Village-Badonikala, Tehsil - Badoni, Dist. Datia MP by M/s D.S. Construction, D-523, Suresh Nagar, Thatipur, Gwalior MP.
- (2) The Prior Environmental Clearance letter was issued SEIAA vide L.No. 4938/SEIAA/16 dtd.6.1.2017 in the name of " M/s D.S. Construction, D-523, Suresh Nagar, Thatipur, Gwalior. MP.
- (3) It is noted that PP has requested vide no Nil dtd.16.3.2020 to make amendment in the Prior EC letter by changing the name of PP of the mining project namely " M/s KP Singh Bhadoriya Contractor R/o E-46/A Balwant Nagar Thatipur dist-Gwalior MP." in place of M/s D.S. Construction, D-523, Suresh Nagar, Thatipur, Gwalior. MP. "
- (4) It is noted that in support of his request the PP has submitted the following documents
 - i. No objection letter of previous Project Proponent (to whom prior EC was granted) for transfer of prior EC in the name of **M/s KP Singh Bhadoriya Contractor R/o E-46/A Balwant Nagar Thatipur dist-Gwalior MP.**
 - ii. Notarised affidavit of MP State Mining Corporation, Gwalior MP."mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.
 - iii. Copy of Prior EC issued by SEIAA vide letter No. 4938/SEIAA/16 dtd.6.1.2017.
 - iv. Copy of Environmental Management Plan of M/s KP Singh Bhadoriya Contractor R/o E-46/A Balwant Nagar Thatipur dist-Gwalior MP.
 - v. Copy of Approved Mining Plan with Replenishment Plan of M/s KP Singh Bhadoriya Contractor R/o E-46/A Balwant Nagar Thatipur dist-Gwalior MP.
 - vi. Lease transfer order issued by Mineral Resource Department order to of M/s KP Singh Bhadoriya Contractor vide letter No. 1189/132/2020/12/1 dated 2.3.2020.
- (5) It is noted that in EIA Notification 2006 as per **Para-11 Transferability of Environmental Clearance (EC)** there is a provision of transferring the EC.

Para-11 :- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity

In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued SEIAA on 6.1.2017 in the name of "M/s D.S. Construction, D-523, Suresh Nagar, Thatipur, Dist-Gwalior MP." is hereby transferred to **M/s KP Singh Bhadoriya Contractor R/o E-46/A Balwant Nagar Thatipur dist-Gwalior MP. for Sand Quarry in an area of 23.0 ha. for production capacity 57,500 cubic meter per year at Khasra no.-173, 174 at Village-Badonikala, Tehsil - Badoni, Dist. Datia (MP).**" on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. **All concerned be informed accordingly.**

In view of above, prior EC issued to M/s D.S. Construction, D-523, Suresh Nagar, Thatipur, Dist-Gwalior MP. by SEIAA vide letter No. 4938/SEIAA/16 dtd.6.1.2017 is hereby transferred to **M/s KP Singh Bhadoriya Contractor R/o E-46/A Balwant Nagar Thatipur dist-Gwalior MP. for Sand Quarry in an area of 23.0 ha. for production capacity 57,500 cubic meter per year at Khasra no.-173, 174 at Village-Badonikala, Tehsil - Badoni, Dist. Datia (MP).**" on the same terms & conditions and validity period under which the prior environmental clearance was initially granted.


