The case was discussed in 566<sup>th</sup> SEIAA meeting dtd 21.08.19 and it has been recorded that .....

"The prior EC was issued to M/s Vijay Marbles, Shri Vijay Kumar Mittal, Partner, 24, Commercial Complex, Housing Board Colony, Katni (MP)-483501 vide Letter No. 10182/SEIAA/15 dtd. 02.01.2016 for an area of 9.933 ha. at Village - Kotalde, Tehsil-Chandiya, Dist- Umariya (MP).

Applicant M/s S.K. Marbles, Shri Suresh Kumar Mittal has submitted the following documents in support of his request:

1. Application for transfer of Prior EC in favour of the M/s S.K. Marbles, Shri Suresh Kumar Mittal.
2. No objection notarised affidavit of previous Project Proponent (to whom prior EC was granted) for transfer of prior EC in the name of M/s S.K. Marbles, Shri Suresh Kumar Mittal.
3. Notarised affidavit of M/s S.K. Marbles, Shri Suresh Kumar Mittal mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.
4. Lease transfer order issued by Office of Collector (Mining Division) to M/s S.K. Marbles, Shri Suresh Kumar Mittal vide letter No. 620/खनिज/2019 dated 08.03.2019.
5. Copy of Prior EC issued by MPSEIAA vide letter no. No. 10182 dtd. 02.01.2016.

As per the notification issued by MoEF&CC on 14.09.2006, the policy on transferability of EC is as follows:-

**11. Transferability of Environmental Clearance (EC):**

A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance

was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases

After detailed discussions on the MoEF&CC Notification regarding transferability and perusal of the above information, it has been decided to transfer the Prior EC issued on 02.01.2016 in favour of M/s S.K. Marbles, Shri Suresh Kumar Mittal, 26 Commercial Complex, Housing Board District Katni (MP)-483504 in the place M/s Vijay Marbles, Shri Vijay Kumar Mittal, Partner, 24, Commercial Complex, Housing Board Colony, Katni (MP)-483501 for Stone Boulder Quarry (Opencast Manual/ Semi Mechanized Method) in an area of 9.933 ha. for production capacity of 19,700 cum/year at Khasra No. 113, 114, 145, 146, 147, 144, 149, 156/1(P) at Village-Kotalde, Tehsil-Chandiyia, Dist- Umariya (MP) on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. Copy to PP and all concerned. "

Hence, it was decided to transfer the Prior EC in the name of M/s S.K. Marbles, Shri Suresh Kumar Mittal, 26 Commercial Complex, Housing Board District Katni (MP)-483504 with the same terms & conditions under which the Prior Environmental Clearance was initially granted, and for the same production capacity and validity period.
