- "It is noted that the PP had applied in Form-7 for transfer of Prior Environmental Clearance for Metal stone Quarry (Opencast Semi-mechanized Method) in an area of 3.00 Ha for production capacity of 60,000 M3 per year at khasra no 672 at Village - Bilhari Kalan, Tehsil - Datia (Badouni), District. - Datia (M.P.) by M/s Star Stone Industries Partner Shree Brijesh Singh Tomar, S/o Shree Udai Singh Tomar R/o 30 Mane ka
- The Prior Environmental Clearance letter was issued by SEIAA vide L.No. 936 dated 06.06.2013 in the name of Baglamukhi Stone Crusher, Partner Shree Rajeev Jain R/o D-9 Gandhi Nagar District-Gwalior (M.P.)
- 3. It is noted that in support of his request the PP has submitted the following documents:

No Objection Certificate in the form of Notarised Affidavit submitted by M/s Baglamukhi Stone Crusher, Partner Shree Rajeev Jain R/o D-9 Gandhi Nagar District- Gwalior (M.P.), for transfer of prior EC in the name of M/s Star Stone Industries Partner Shree Brijesh Singh Tomar S/o Shree Udai Singh Tomar R/o 30 -Mane ka Pura porsa Morena District Morena (MP) mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued..

- iv. It is noted that in EIA Notification 2006 as per Para-11 Transferability of Environmental Clearance (EC) there is a provision of transferring the EC:

Para - 11. Transferability of Environmental Clearance (EC):

A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases

In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued by SEIAA vide letter no 936 dated 06.06.2013 in the name of " M/s Baglamukhi Stone Crusher,Partner Shree Rajeev Jain R/o D-9 Gandhi Nagar District- Gwalior (M.P.) is hereby transferred to M/s Star Stone Industries Partner Shree Brijesh Singh Tomar S/o Shree Udai Singh Tomar R/o 30 -Mane ka Pura porsa Morena District Morena (MP) for Metal Stone Quarry (Opencast Semi-mechanized Method) in an area of 3.00 Ha for production capacity of 60,000 M3 per year at khasra no 672 at Village Bilhari Kalan, Tehsil -Badouni, District.- Datia (M.P.)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. All concerned be informed accordingly".

Hence, it was decided to transfer the Prior EC in the name of M/s Star Stone Industries Partner Shree Brijesh Singh Tomar S/o Shree Udai Singh Tomar R/o 30 -Mane ka Pura porsa Morena District Morena (MP) with the same terms & conditions under which the Prior Environmental Clearance was initially granted, and for the same production capacity and validity period.
