The case was discussed in 669<sup>th</sup> SEIAA meeting dtd 26.03.2021 and it has been recorded that ......

- (1) "It was noted that the PP had applied in Form-7 for Prior Environmental Clearance for stone quarry in an area of 1.00 ha at Khasra no. 59/2 for production capacity of 5700 cum /year at Village-Dhorani, Tehsil & Dist.- Khandwa (MP) by M/s Krishna Stone Crusher, Partner, Shri Bharat Meghwani S/o Shri Chandrabhan Meghwani R/o 341 Vidya Nagar, Khandwa and Shri Rohit Parchani S/o Shri Rajesh Parchani R/o Sindhi colony Khandwa, District Khandwa (MP) 450001.
- (2) The Prior Environmental Clearance letter was issued by SEIAA vide L.No. 5796/SEIAA/15 dated 26.09.2015 in the name of Shri Anil Yadav, S/o Shri Asharam Yadav R/o Near Santoshi Mata Mandir, Indore Road, District Khandwa (MP).
- (3) It is noted that in support of his request the PP has submitted the following documents

  - ii. Notarised affidavit of M/s Krishna Stone Crusher, Partner, Shri Bharat Meghwani S/o Shri Chandrabhan Meghwani R/o 341 Vidya Nagar, Khandwa and Shri Rohit Parchani S/o Shri Rajesh Parchani R/o Sindhi colony Khandwa, District Khandwa (MP) mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.
  - iii. Copy of Prior EC issued by SEIAA vide L.No. 5796/ SEIAA/ 15 dataed 26.09.2015.

- Lease transfer order issued by Office of Collector (Mining Division) Khnadwa to M/s Krishna Stone Crusher, Partner, Shri Bharat Meghwani S/o Shri Chandrabhan Meghwani R/o 341 Vidya Nagar, Khandwa and Shri Rohit Parchani S/o Shri Rajesh Parchani R/o Sindhi colony Khandwa, District - Khandwa (MP) vide letter No. 1046/Khanij/2020 dated 22.11.2020.
- (4) It is noted that in EIA Notification 2006 as per Para-11 Transferability of Environmental Clearance (EC) there is a provision of transferring the EC.
  - Para-11 :- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.
- (1) In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued on 26.09.2015 in the name of " Shri Anil Yadav, S/o Shri Asharam Yadav R/o Near Santoshi Mata Mandir, Indore Road, District - Khandwa (MP) is hereby transferred to M/s Krishna Stone Crusher, Partner, Shri Bharat Meghwani S/o Shri Chandrabhan Meghwani R/o 341 Vidya Nagar, Khandwa and Shri Rohit Parchani S/o Shri Rajesh Parchani R/o Sindhi colony Khandwa, District - Khandwa (MP) for Stone Quarry in an area of 1.00 ha at Khasra no. 59/2 for production capacity of 5700 cum /year at Village-Dhorani, Tehsil & Dist.- Khandwa (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. All concerned be informed accordingly."

In view of above, prior EC issued to Shri Anil Yadav, S/o Shri Asharam Yadav R/o Near Santoshi Mata Mandir, Indore Road, District - Khandwa (MP) by SEIAA vide letter No. 5796/ SEIAA/ 15 dataed 26.09.2015 is hereby transferred to M/s Krishna Stone Crusher, Partner, Shri Bharat Meghwani S/o Shri Chandrabhan Meghwani R/o 341 Vidya Nagar, Khandwa and Shri Rohit Parchani S/o Shri Rajesh Parchani R/o Sindhi colony Khandwa, District - Khandwa (MP) for Stone Quarry in an area of 1.00 ha at Khasra no. 59/2 for production capacity of 5700 cum /year at Village-Dhorani, Tehsil & Dist.- Khandwa (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted.
