Bafna R/o SM-28, Padmanabhpur, Durg (C.G.).

The case was discussed in 570th SEIAA meeting dtd 07.09.19 and it has been recorded that

" The prior EC was issued to Shri Shashi Mohan Gupta R/o Village & Post Hanumana, Tehsil Hanumana, District Rewa (M.P.) – 486335 vide Letter No. 614/SEIAA/13 dtd. 17.05.2013 for an area of 4.00 ha at Village - Majh Kathairi, Tehsil - Sarai , District - Singrauli (MP).

Applicant M/s Siddhivinayak Crushing Unit, Partner Shri Anand Bafna has submitted the following documents in support of his request:

- 4. Lease transfer order issued by Office of Collector (Mining Division) Singrauli to M/s Siddhivinayak Crushing Unit, Partner Shri Anand Bafna vide letter No. 2694/खनिज / उ.प. / हस्ता. / 2019 dated 25.06.2019.
- 5. Copy of Prior EC issued by MPSEIAA vide letter no. No. 614 dtd. 17.05.2013.

As per the notification issued by MoEF&CC on 14.09.2006, the policy on transferability of EC is as follows:-

11. Transferability of Environmental Clearance (EC):

A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferoe with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases

After detailed discussions on the MoEF&CC Notification regarding transferability and perusal of the above information, it has been decided to transfer the Prior EC issued on 17.05.2013 in favour of M/s Siddhivinayak Crushing Unit, Partner Shri Anand Bafna S/o Shri K.C. Bafna R/o SM-28, Padmanabhpur, Durg (C.G.) in the place Shri Shashi Mohan Gupta R/o Village & Post Hanumana, Tehsil Hanumana, District Rewa (M.P.) – 486335 for Stone Boulder Quarry (opencast manual method) in an area of 4.00 ha for production capacity of 20000 cum/year at Khasra No. 1216/1 at Village - Kathairi, Tehsil - Sarai , District - Singrauli (MP) on the same terms & conditions and validity period under which the prior environmental clearance was initially granted.
