The case was discussed in 693rd SEIAA meeting dtd. 25.11.2021 and it was recorded that

(1) It is noted that the PP had applied in Form-7 for transfer of Prior Environmental Clearance for Basalt Stone Boulder Quarry in an area of 1.00 ha. for production capacity of 4500 cum per annum at Khasra No.581, Village-Majhaniya, Tehsil-Shajapur, District-Shajapur (MP) by Shri Prem Singh Rajawat S/o Shri Hajari Lal Rajawat, Village-Majhaniya, Tehsil-Shajapur, District-Shajapur (MP)-465001

(2) The Prior Environmental Clearance letter was issued by SEIAA vide 4653/ dated 12.08.2015 in the name of Shri Prem Singh Rajawat S/o Shri Hajari Lal Rajawat, Village-Majhaniya,

Tehsil-Shajapur, District-Shajapur (MP)-465001

(3) It is noted that in support of his request the PP has submitted the following documents:

- No Objection Certificate in the form of Notarized Affidavit submitted by Shri Prem Singh Rajawat S/o Shri Hajari Lal Rajawat, Village-Majhaniya, Tehsil-Shajapur, District-Shajapur (MP)-465001 for transfer of prior EC in the name of Shri Narendra Singh Rajawat, Village Majhaniya, Tehsil-Shajapur, District-Shajapur (MP)-465001
- Notarized affidavit of Narendra Singh Rajawat, Village Majhaniya, Tehsil-Shajapur, (ii) District-Shajapur (MP)-465001 mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.
- Copy of Prior EC issued by SEIAA vide 4653/ dated 12.08.2015. (iii)
- Copy of Environmental Management Plan submitted by Narendra Singh Rajawat, Village Majhaniya, Tehsil-Shajapur, District-Shajapur (MP)-465001
- Copy of Mine Plan Transfer letter of Directorate of Geology & Mining, Indore, vide (V) letter No. 1967 dated 03.09.2021.

- (vi) Lease transfer letter issued by Collector (Mining Division) district Shajapur vide order no. 993 dated 12.07.2021 (Validity upto 27.01.2024) to Narendra Singh Rajawat, Village Majhaniya, Tehsil-Shajapur, District-Shajapur (MP)-465001
- (4) It is noted that in EIA Notification 2006 as per Para-11 Transferability of Environmental Clearance (EC) there is a provision of transferring the EC.

Para-11:- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases

(5) EIA Notification 2006 (Amendment dated 13.07.2021) as per the sub-section (6) of section 8A of the Mines and Minerals (Development and Regulation) Act, 1957 (67 of 1957) provides that:

"Notwithstanding anything contained in sub-sections (2), (3) and sub-section (4), the period of lease granted before the date of commencement of the Mines and Minerals (Development and Regulation) Amendment Act, 2015 (10 of 2015), where mineral is used for other than captive purpose, shall be extended and be deemed to have been extended up to a period ending on the 31st March, 2020 with effect from the date of expiry of the period of renewal last made or till the completion of renewal period, if any, or a period of fifty years from the date of grant of such lease, whichever is later, subject to the condition that all the terms and conditions of the lease have been complied with"

In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued by SEIAA vide L.No. 4653/ dated 12.08.2015 in the name of Shri Prem Singh Rajawat S/o Shri Hajari Lal Rajawat, Village-Majhaniya, Tehsil-Shajapur, District-Shajapur (MP)-465001 is hereby transferred to Shri Narendra Singh Rajawat, Village Majhaniya, Tehsil-Shajapur, District-Shajapur (MP)-465001 for Basalt Stone Boulder Quarry in an area of 1.00 ha. for production capacity of 4500 cum per annum at Khasra No.581, Village-Majhaniya, Tehsil-Shajapur, District-Shajapur (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted with following additional conditions:-

i. PP should ensure to submit half yearly compliance report duly certified by Regional Office, MoEF&CC, GoI, Bhopal. If PP is failed to upload or submit two consecutive half yearly compliance reports of EC conditions to concerned authority (SEIAA and Regional Office, MoEF&CC, GoI, Bhopal) than prior environmental clearance issued to PP will automatically be treated as cancelled/ revoked as per SEIAA Office Memorandum No. 930/SEIAA/2019 dated 30.05.2019.
