The case was discussed in 622<sup>nd</sup> SEIAA meeting dtd. 19.06.2020 and it was recorded that.....

- i. It was noted that the PP had applied in Form-I for Prior Environmental Clearance of 5.00 ha. for production capacity of 5300 cum/year at khasra no. 151 at Village - Anjad, Tehsil - Anjar, District- Barwani (MP) by Chief Municipal Officer, Nagar Parisad Anjar, Tehsil - Anjad, District- Barwani (MP).
- ii. The Prior Environmental Clearance letter was issued by SEIAA, vide L.No. 1771/SEIAA/18 dated 28.02.18 in the name of "Chief Municipal Officer, Nagar Parisad Anjad, Tehsil - Anjad, District- Barwani (MP)".
- iii. It is noted that PP has requested vide letter no. nil dtd. 13.06.2020 to make amendment in Prior EC letter by changing the name of PP in mining project namely **Ambey Suppliers Pvt. Ltd. Authorized Person Shri Jitendra Singh Bhadoriya, B-3, First Floor, Saket, New Delhi-110017** in place of **Chief Municipal Officer, Nagar Parisad Anjad, Tehsil - Anjad, District- Barwani (MP)**.
- iv. It is noted that in support of his request the PP has submitted the following documents:

Authorized Person Shri Jitendra Singh Bhadoriya, B-3, First Floor, Saket, New Delhi-110017**, mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.

- V. It is noted that in EIA Notification 2006 as per **Para-11 Transferability of Environmental Clearance (EC)** there is a provision of transferring the EC.

**Para-11:-** A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

In context of above, it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued by SEIAA on 28.02.18 in the name of "**Chief Municipal Officer, Nagar Parisad Anjad, Tehsil – Anjad, District- Barwani (MP)**" is hereby transferred to "**Ambey Suppliers Pvt. Ltd., Authorized Person Shri Jitendra Singh Bhadoriya, B-3, First Floor, Saket, New Delhi-110017**" for River Sand- Bajri Deposit (Opencast Manual Method) in an area of 5.00 ha. for production capacity of 5300 m<sup>3</sup>/year at Khasra no. 151 at Village -Anjad, Tehsil - Anjad, District- Barwani (MP) on the same terms & conditions, production capacity and validity period under which the prior Environmental Clearance was initially granted.
