- "It is noted that the PP had applied in Form-7 for transfer of Prior Environmental Clearance for Sand Deposit Quarry in an area of 19.00 ha. for production capacity of 1,90,000 cum/year at Khasra no. 546, 850 Village-Khairauli, Tehsil-Mehgaon, District - Bhind (MP) by M/s Power Mech Projects Limited, Plot No. 248, Sector -2, Shakti Nagar, Habibganj, Bhopal (MP) - 462002.
- The Prior Environmental Clearance letter was issued by SEIAA vide L.No. 1899/2018 dated 09.03.2018 in the name of Sarpanch, Gram Panchayat, Kahirauli, Tehsil – Mehgaon, District – Bhind (MP).
- It is noted that in support of his request the PP has submitted the following documents
  - No Objection Certificate in the form of Notarised Affidavit submitted by Chief Executive Officer, Janpad Panchayat, Mehgaon, District – Bhind on behalf of previous project proponent for transfer of prior EC in the name of M/s Power Mech Projects Limited, Plot No. 248, Sector -2,
  - Notarised affidavit of M/s Power Mech Projects Limited, Plot No. 248, Sector -2, Shakti Nagar, Habibganj, Bhopal (MP) - 462002 mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions III.
  - Copy of Prior EC issued by SEIAA vide L.No. 1899/2018 dated 09.03.2018.
  - Copy of Environmental Management Plan of M/s Power Mech Projects Limited, Plot No. 248, iv. Sector -2, Shakti Nagar, Habibganj, Bhopal (MP) - 462002.
  - Copy of Approved Mining Plan of M/s Power Mech Projects Limited, Plot No. 248, Sector -2, Shakti Nagar, Habibganj, Bhopal (MP) - 462002.
  - Lease transfer order issued by Mineral Resource Department to M/s Power Mech Projects vi. Limited, Plot No. 248, Sector -2, Shakti Nagar, Habibganj, Bhopal (MP) vide letter No. 2775/
- It is noted that in EIA Notification 2006 as per Para-11 Transferability of Environmental Clearance (EC)
  - Para-11 :- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions

under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued by DEIAA on 09.03-2018 in the name of " Sarpanch, Gram Panchayat, Kahirauli, Tehsil - Mehgaon, District - Bhind (MP) is hereby transferred to M/s Power Mech Projects Limited, Plot No. 248, Sector -2, Shakti Nagar, Habibganj, Bhopal (MP) -462002 for Sand Deposit Quarry in an area of 19.00 ha. for production capacity of 1,90,000 cum/year at Khasra no. 546, 850 Village-Khairauli, Tehsil-Mehgaon, District-Bhind (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. All concerned be informed accordingly."

In view of above, prior EC issued to Sarpanch, Gram Panchayat, Kahirauli, Tehsil - Mehgaon, District - Bhind (MP) by SEIAA vide L.No. 1899/2018 dated 09.03.2018 is hereby transferred to M/s Power Mech Projects Limited, Plot No. 248, Sector -2, Shakti Nagar, Habibganj, Bhopal (MP) -462002 for Sand Deposit Quarry in an area of 19.00 ha. for production capacity of 1,90,000 cum/year at Khasra no. 546, 850 Village-Khairauli, Tehsil-Mehgaon, District-Bhind (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted.
