Ltd, HIG-5, Deendayal Nagar, Phase-1, Kanth Road, Muradabad, (UP).- Regarding transfer of EC in the name of Shri Shishir Khandar, Owner R/o Samashish Bhavan, 18 Malik Complex, Tenament Hotel, Airport Center Point, Somalwada, Wardha Road, Nagpur - 440025 (Maharashtra).

The case was discussed in 663rd SEIAA meeting dtd 26.02.2021 and it has been recorded that

- i. "It is noted that the PP had applied in Form-7 for transfer of Prior Environmental Clearance for sand quarry in an area of 10.20 for production capacity of 125000 cum per year at Khasra no. 136, 202 & 203 at Village-Sayra, Tehsil - Sausar, Dist.- Chhindwara (MP) by M/s Sainik Foods Pvt. Ltd, HIG-5, Deendayal Nagar, Phase-1, Kanth Road, Muradabad (UP).
- ii. The Prior Environmental Clearance letter was issued by SEIAA vide L.No. 279/SEIAA/18 dated 07.05.2018 in the name of "M/s Sainik Foods Pvt. Ltd, HIG-5, Deendayal Nagar, Phase-1, Kanth Road, Muradabad (UP)".
- iii. It is noted that in support of his request the PP has submitted the following documents:
 - a) No Objection Certificate in the form of Notarised Affidavit submitted by District Mining Officer, Chhindwara (as per OM dated 14.01.20 issued by MP-SEIAA) on behalf of previous PP M/s Sainik Foods Pvt. Ltd, HIG-5, Deendayal Nagar, Phase-1, Kanth Road, Muradabad (UP) for transfer of prior EC in the name of Shri Shishir Khandar, Owner R/o Samashish Bhavan, 18 Malik Complex, Tenament Hotel, Airport Center Point, Somalwada, Wardha Road, Nagpur 440025 (Maharashtra).
 - b) Notarised affidavit of Shri Shishir Khandar, Owner R/o Samashish Bhavan, 18 Malik Complex, Tenament Hotel, Airport Center Point, Somalwada, Wardha Road, Nagpur - 440025 (Maharashtra) mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.
 - c) Copy of Prior EC issued by SEIAA, vide L.No. 279/SEIAA/18 dated 07.05.2018.
 - d) Copy of Environmental Management Plan of Shri Shishir Khandar, Owner R/o Samashish Bhavan, 18 Malik Complex, Tenament Hotel, Airport Center Plient, Somalwada, Wardha Road, Nagpur - 440025 (Maharashtra).
 - e) Copy of Approved Mining Plan with Replenishment Plan of Shri Shishir Khandar, Owner R/o Samashish Bhavan, 18 Malik Complex, Tenament Hotel, Airport Center Point, Somalwada, Wardha Road, Nagpur - 440025 (Maharashtra).

- f) Lease transfer order issued by Mineral Resource Department to Shri Shishir Khandar, Owner R/o Samashish Bhavan, 18 Malik Complex, Tenament Hotel, Airport Center Point, Somalwada, Wardha Road, Nagpur 440025 (Maharashtra) vide letter No. 1013/132/2020/12/1/ dated 18.02.2021.
- iv. It is noted that in EIA Notification 2006 as per Para-11 Transferability of Environmental Clearance (EC) there is a provision of transferring the EC.
 - Para-11:- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferoe with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

In context of above, it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued by SEIAA on 07.05.2018 in the name of "M/s Sainik Foods Pvt. Ltd, HIG-5, Deendayal Nagar, Phase-1, Kanth Road, Muradabad (UP)" is hereby transferred to "Shri Shishir Khandar, Owner R/o Samashish Bhavan, 18 Malik Complex, Tenament Hotel, Airport Center Point, Somalwada, Wardha Road, Nagpur - 440025 (Maharashtra)." for Sand Mine (opencast manual method) in an area of 10.20 for production capacity of 125000 cum per year at Khasra no. 136, 202 & 203 at Village- Sayra, Tehsil - Sausar, Dist.- Chhindwara (MP) on the same terms & conditions and validity period under which the prior Environmental Clearance was initially granted."

In view of above, prior EC issued to M/s Sainik Foods Pvt. Ltd, HIG-5, Deendayal Nagar, Phase-1, Kanth Road, Muradabad (UP) by SEIAA vide letter No. 279/SEIAA/18 dated 07.05.2018 is hereby transferred to Shri Shishir Khandar, Samashish Bhavan, 18, Malik Complex, Tenament Hotel, Airport Center Plient, Somalwada, Wardha Road, Dist. – Nagpur- 440025 for Sand Mine (opencast manual method) in an area of 10.20 for production capacity of 125000 cum per year at Khasra no. 136, 202 & 203 at Village- Sayra, Tehsil - Sausar, Dist.- Chhindwara (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted.
