The case was discussed in 686th SEIAA meeting dtd 15.09.2021 and it has been recorded that

(1) " It is noted that the PP had applied in Form-7 for transfer of Prior Environmental Clearance for Dolomite Mines Quarry in an area of 1.570 ha. with production capacity of 95288 tonne per annum at Khasra No. 59/1, 60, 62), Village - Hathigarh, Tehsil - Kurai, Dist. Seoni, (MP) by M/S Aron Energy Raipur Prop. Smt. Nitu Agarwal w/o Mr. Sanjay Agarwal R/O Banglow no. 08 Ashoka Platinum , Ashoka Ratan, Vidhan sabha Road , Shankar Nagar Dist. Raipur (C.G.) - 492007

(4) It is noted that in EIA Notification 2006 as per Para-11 Transferability of Environmental Clearance (EC) there is a provision of transferring the EC.

Para-11:- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

(5) EIA Notification 2006 (Amendment dated 13.07.2021) as per the sub-section (6) of section 8A of the Mines and Minerals (Development and Regulation) Act, 1957 (67 of 1957) provides that:

"Notwithstanding anything contained in sub-sections (2), (3) and sub-section (4), the period of lease granted before the date of commencement of the Mines and Minerals (Development and Regulation) Amendment Act, 2015 (10 of 2015), where mineral is used for other than captive purpose, shall be extended and be deemed to have been extended up to a period ending on the 31st March, 2020 with effect from the date of expiry of the period of renewal last made or till the completion of renewal period, if any, or a period of fifty years from the date of grant of such lease, whichever is later, subject to the condition that all the terms and conditions of the lease have been complied with"

In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued by SEIAA vide L.No. 3954 dated 14.01.2020 in the name of " Shri Anil Kumar Modi S/o Late Meghraj Modi, Main Road, Dist. Balaghat, MP – 481001 is hereby transferred to M/S Aron Energy Raipur Prop. Smt. Nitu Agarwal w/o Mr. Sanjay Agarwal R/O Banglow no. 08 Ashoka Platinum, Ashoka Ratan, Vidhan sabha Road, Shankar Nagar Dist. Raipur (C.G.) – 492007 for Dolomite Mine (opencast manual method) in an area of 1.570 ha. with production capacity of 95288 tonne per annum at Khasra No. 59/1, 60, 62 at Village - Hathigarh, Tehsil - Kurai, Dist. Seoni (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted with following additional conditions:-

(1) PP should ensure to submit half yearly compliance report duly certified by Regional Office, MoEF&CC, Gol, Bhopal. If PP is failed to upload or submit two consecutive half yearly compliance reports of EC conditions to concerned authority (SEIAA and Regional Office, MoEF&CC, Gol, Bhopal) than prior environmental clearance issued to PP will automatically be treated as cancelled/ revoked as per SEIAA Office Memorandum No. 930/SEIAA/2019 dated 30.05.2019

In view of above, prior EC issued to Shri Anil Kumar Modi S/o Late Meghraj Modi, Main Road, Dist. Balaghat, MP – 481001 by SEIAA vide letter No. 3954 dated 14.01.2020 is hereby transferred to M/S Aron Energy Raipur Prop. Smt. Nitu Agarwal w/o Mr. Sanjay Agarwal R/O Banglow no. 08 Ashoka Platinum , Ashoka Ratan, Vidhan sabha Road , Shankar Nagar Dist. Raipur (C.G.) – 492007 for **Dolomite Mine** (opencast manual method) in an area of 1.570 ha. with production capacity of 95288 tonne per annum at Khasra No. 59/1, 60, 62 at Village - Hathigarh, Tehsil - Kurai, Dist. Seoni (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted with following additional conditions :

(1) PP should ensure to submit half yearly compliance report duly certified by Regional Office, MoEF&CC, Gol, Bhopal. If PP is failed to upload or submit two consecutive half yearly compliance reports of EC conditions to concerned authority (SEIAA and Regional Office, MoEF&CC, Gol, Bhopal) than prior environmental clearance issued to PP will automatically be treated as cancelled/ revoked as per SEIAA Office Memorandum No. 930/SEIAA/2019 dated 30.05.2019.."
