(6000 cum per annum) (Khasra No. 757), Village - Jamgod, Tehsil - Dewas, Dist. Dewas by Ku. Naina Pawar D/o Shri Liladhar Panwar, Add. 328 Shiv Shakti Nagar, Tehsil & District Dewas

 The Prior Environmental Clearance letter was issued DEIAA (Case no.185/2018) vide L.No. 216/DEIAA/18 dtd.04.03.2018 in the name of "Ku. Naina Pawar D/o Shri Liladhar Panwar, Add. 328 Shiv Shakti

It is noted that in EIA Notification 2006 as per Para-11 Transferability of Environmental Clearance (EC)

there is a provision of transferring the EC.

Para-11 :- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued SEIAA on 04.03.2018 in the name of " Ku. Naina Pawar D/o Shri Liladhar Panwar, Add. 328 Shiv Shakti Nagar, Tehsil & District Dewas " is hereby transferred to "M/s Udai Mines, Partner - Shri Udai Mishra, R/o Scheme no. 94, Bharfani Dham Chouraha, Ring road , Dist. Indore, MP - 455001-". for Stone Quarry(Opencast Mechanized Method) in an area of 3.0 ha. (6000 cum per annum) (Khasra No. 757), Village - Jamgod, Tehsil - Dewas, Dist.
