The case was discussed in 663rd SEIAA meeting dtd 26.02.2021 and it has been recorded that

- "It is noted that the PP had applied in Form-7 for transfer of Prior Environmental Clearance of Stone Quarry in an area of 4.0 ha. for production capacity of 42000 cum per annum at Khasra No. 126 at Village - Bibdod, Tehsil - Ratlam, Dist. - Ratlam (MP) by Shri Jay Luniya S/o Shri Jindas Luniya, 69 Jain Colony, Dist - Ratlam (MP) - 457001.
- ii. The Prior Environmental Clearance letter was issued by DEIAA, Dist. Ratlam vide L.No. 281/DEIAA-DEAC/2016-17 dated 31.05.2016 in the name of "Shri Jay Kumar Luniya S/o Shri Jindas Luniya, 69 Jain Colony, Dist Ratlam (MP)".
- iii. It is noted that in support of his request the PP has submitted the following documents:
 - a) No Objection Certificate in the form of Notarised Affidavit submitted by Shri Jay Kumar Luniya S/o Shri Jindas Luniya, 69 Jain Colony, Dist Ratlam for transfer of prior EC in the name of M/s Kamdhenu Stone & Sand, Partner, Shri Sanjay Patwala, Partner, 24, Teachers Colony, Dist. Ratlam (MP).
 - b) Notarised affidavit of M/s Kamdhenu Stone & Sand, Shri Sanjay Patwala, Partner, 24, Teachers Colony, Dist. - Ratlam (MP) mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.
 - c) Copy of Prior EC issued by DEIAA, Dist. Narsinghpur vide L.No. 281/ DEIAA-DEAC/ 2016-2017 dated 31.05.2016.
 - d) Copy of Environmental Management Plan of M/s Kamdhenu Stone & Sand, Partner, Shri Sanjay Patwala, Partner, 24, Teachers Colony, Dist. Ratlam (MP).
 - e) Copy of Approved Mining Plan of M/s Kamdhenu Stone & Sand, Shri Sanjay Patwala, Partner, 24, Teachers Colony, Dist. - Ratlam (MP).
 - Lease transfer order issued by Office of the Collector (Mining Division) to M/s Kamdhenu Stone & Sand, Shri Sanjay Patwala, Partner,, 24, Teachers Colony, Dist. Ratlam (MP) vide letter No. 942/Khanij/ 2019-2020 dated 18.12.2019.

- It is noted that in EIA Notification 2006 as per Para-11 Transferability of Environmental Clearance (EC) iv. there is a provision of transferring the EC.
 - Para-11:- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

In context of above, it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued by DEIAA, Dist. - Ratlam on 31.05.2016 in the name of "Shri Jay Kumar Luniya S/o Shri Jindas Luniya, 69 Jain Colony, Dist - Ratlam (MP)" is hereby transferred to "M/s Kamdhenu Stone & Sand, Partner, Shri Sanjay Patwala, Partner, 24, Teachers Colony, Dist. - Ratlam" for Stone Quarry in an area of 4.00 ha. for production capacity of 42000 cum per annum at Khasra No. 126 at Village - Bibdod, Tehsil - Ratlam, Dist. - Ratlam (MP) on the same terms & conditions and validity period under which the prior Environmental Clearance was initially granted."

In view of above, prior EC issued to Shri Jay Kumar Luniya S/o Shri Jindas Luniya, 69 Jain Colony, Dist - Ratlam (MP) by DEIAA vide letter No. 281/ DEIAA-DEAC/ 2016-2017 dated 31.05.2016 is hereby transferred to M/s Kamdhenu Stone & Sand, Partner, Shri Sanjay Patwala, Partner, 24, Teachers Colony, Dist. - Ratlam" for Stone Quarry in an area of 4.00 ha. for production capacity of 42000 cum per annum at Khasra No. 126 at Village - Bibdod, Tehsil - Ratlam, Dist. - Ratlam (MP) for Stone Quarry in an area of 4.00 ha. for production capacity of 42000 cum per annum at Khasra No. 126 at Village - Bibdod, Tehsil - Ratlam, Dist. - Ratlam (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted.
